CONDITIONS:

Cold, crisp and clear evening with a temp of 43 degrees. Quiet evening.

NOTABLE INCIDENTS:

22:11 HRS 3900 BLOCK OF 17TH STREET – Intoxicated Person (811): 24 yo HMA seen vomiting outside of the gate of a building on 17th street. He was with a HFA. After we approached to check on his condition, he staggered backwards and fell backwards fairly instantly, and the back of his head made contact with the pavement. Brian immediately asked Jeff to call 911. His eyes were closed and he was non-responsive initially but he was breathing; we suspected a concussion at least. Brian noted there were trace levels of the male's blood on

the pavement. He was out for a couple of minutes before starting to be very minimally responsive.

The HFA was hysterical, trying to forcibly rouse him, climbing all over him. We restrained her, but Brian called Patrol Special to assist. At this point, male was responding and attempting stand up, but we insisted he not stand up. Antjuan Taswell of the PSP arrived at this point. Paramedics arrived shortly after that. Ambulance arrived about 10 minutes later.

@ 22:36, both were taken via ambulance to the hospital.

Brian checked at Orphan Andy's. They had eaten there but were sloppy and falling off of their stools. They were thrown out without paying the bill

- 22:42 HRS 2300 BLOCK MARKET STREET Well Being Check (910):
 Wellness check on a sleeping WMA in the entryway of a business. There was a
 posted no trespass sign on the window. The WMA moved on, declining
 assistance.
- 24:00 HRS CASTRO MISSION HEALTH CENTER ON 17TH ST Well Being Check (910): A WMA was sleeping in the middle of parking spot in the parking lot on the east side of the facility where he was risk of being run over by a car attempting to park. We explained that DPH property was private property and that he'd have to move. We said we could call HOT or the police. He agreed to have HOT pick him and to move out of the middle of parking space. Brian called HOT and spoke to Nikolai and was informed that someone will pick him up within 30 minutes.
- 00:08 HRS 300 BLOCK NOE STREET Well Being Check (910): Wellness check of BMA, but No trespassing sign was invalid.
