CCOP PATROL REPORT: SATURDAY 02/07/2015 Roving Foot Patrol (RFP) - 21:50-00:15

CONDITIONS:

Cool temperatures in the mid 50s, clear w/ good visability, mildy humid.

NOTABLE INCIDENTS:

- 22:32 HRS CASTRO THEATRE PARKING LOT Trespass (): WFA in passenger's side of a Silver 4-D Mazda wearing a gold dress sitting in the car with no noticeable intention of getting out. License plate was a new Sunnyvale ford generic off-the-lot License plate. We informed her that she was not allowed to remain in the car while parked in the parking lot. They stated that they would be leaving the parking lot soon.
- 22:52 HRS 4129 18th STREET Public Safety Danger (): Due to the inclement weather from the previous day, there was a fallen tree branch of significant size partially on the sidewalk. With the line from badlands reaching far enough back, there was very limited room to walk so we moved the branch to the street and out of the way of it being a trip hazard.
- 23:01 HRS NE corner of Castro and 18th street Sidewalk Obstruction (22): One BMA and One WMA with bags of luggage blocking a clear path of the sidewalk, dancing around and, at one brief moment as witnessed by one member of our patrol, exposing himself. We asked them to keep the luggage against the building and not in the middle of the sidewalk. They were a little oblivious to the happenings around them yet also a bit hyper leading us to believe maybe using drugs of some sort. BMA was wearing a black sweater and tennis shoes. WMA was wearing a beanie with an unbuttoned collared shirt and jeans.
- 23:17 HRS 2300 BLOCK MARKET ST Noise Nuisance (415): 3 AMAs and 2 AFAs (possibly Pacific Islander) making loud noises and yelling at one another in a conversational way as opposed to argumentative. We heard from across the street and headed over. As we walked up the noise level subsided but we decided to linger a bit longer just in case.
- 23:27 HRS 2400 BLOCK MARKET STREET Trespass (601): 2 WMAs sleeping and essentially trespassing in a Parking car port. We asked them to move themselves and their belongings off of the private property. The older of the two got up to look at the no trespassing sign which he stated was out of date, but regardless of dates, it is still considered private property on which they were not allowed on unless they are tenants of the building. After about a 5 minute wait and debate, they moved to just behind the elevator leading down to the underground muni station.
- 23:45 HRS 3900 17TH STREET Well Being Check (910): Well being check on a BMA lying/sleeping against building covered by a red blanket. He indicated that he was in no need of assistance.

- 23:50 HRS 00 BLOCK POND STREET Urinating in Public (153): As we walk North on Pond towards 16th Street, we pass a 4 door Ford SUV with Lic# Some people had already exited the car and were walking past us heading in the opposite direction but both doors were still open. The driver was putting on a jacket but when we turned and flashed a light we noticed a HMA peeing in the plantar along the side of the Public Health building. We quickly walked over and told him that it is against the law to pee in public and that if our 10-B officer were with us, he would have a ticket for \$300 in his hot little pee covered hands by now. He ignored us and shrugged it off as he walked away while we were explaining all this to him until they were made aware that we were also recording the license plate of the car. They then became defensive and finally listened to what we were trying to tell them.
- 23:54 HRS EUREKA VALLEY LIBRARY Well Being Check (910): One Male and One Female adult sleeping next to each other under a blanket or sleeping bags. We woke them up to make sure they were doing okay and responsive and they declined any calls or assistance.
- 23:57 HRS 2300 block MARKET STREET Smoking (sfhc 1009.22(14)): A few people were smoking alongside the building and we told them that they would have to move to the curb to smoke and they could not smoke that close to the businesses. Some expressed annoyance in their facial expressions but none disputed our request.
- 00:09 HRS 4100 BLOCK 18TH ST Smoking (sfhc 1009.22(14)): Two WMAs and one HMA smoking in the line for Badlands. We explained to them that they were not allowed to smoke in the line that close to the building and that if they wanted to smoke they would have to more to the curb past where the red tape is marked on the sidewalk. The two WMAs were not pleased by this and asked if we were the smoking police. All eventually complied.
