# CCOP PATROL REPORT: FRIDAY 02/20/2015 Roving Foot Patrol (RFP) - 22:30-02:30

#### **PATROLLERS:**

### **CONDITIONS:**

Cool temperatures around 55 degrees, clear with good visibility.

## **NOTABLE INCIDENTS:**

• 22:35 HRS DIAMOND STREET & 19<sup>TH</sup> STREET – A Priority SFPD Radio Call (): As we deployed for patrol we heard SFPD respond to an A priority call two blocks from our current position. As three SFPD units were 97 (at the scene) and it was under control, we decided to continue our patrol without proceeding to the location. Later in the patrol we received a separate communication regarding

- some homeless people threatening a resident with a chain in the area which led to the A priority call.
- 22:40 HRS 4300 18<sup>th</sup> STREET POST OFFICE Well Being Check (910): We observed an individual sleeping on the sidewalk against the wall of the post office, wrapped head to toe in blankets. We performed a well being check and the individual declined medical and HOT assistance.
- 23:00 HRS 3518 16<sup>TH</sup> STREET Well Being Check (910): We observed two
  separate individuals sleeping on the sidewalk against the wall of the adjacent
  buildings. We performed well being checks of both individuals. Both declined
  medical and HOT assistance.
- 23:49 HRS 2349 MARKET STREET ILLY CAFÉ Well Being Check (910): We observed a WMA sleeping in the doorway of the café. We performed a well being check and the individual declined medical and HOT assistance. The Café did not have a posted MPC-25 so we took no additional action.
- 23:57 HRS 2233 MARKET STREET ONE HOUR CLEANERS Well Being Check (910): We observed a BMA sleeping in a sleeping bag in the doorway to the store. We performed a well being check and the individual declined medical and HOT assistance. An up to date MPC-25 was posted, so we advised the individual he was trespassing and would have to move. He complied.
- 00:05 HRS 1 JOSE SARRIA COURT HARVEY MILK LIBRARY Encampment
  (22): We observed a temporary structure built from a recycle bin and a blanket in
  the South East corner of the library parking lot in front of a locked gate which
  leads to the rear of the library. We roused the individual, confirmed he did not
  require medical or HOT assistance and advised him he would have to remove his
  structure. He complied.
- 00:25 HRS WALGREENS PARKING LOT Suspicious Person in Vehicle (916): We observed a HMA slumped over the wheel of a grey vehicle in one of the City Car Share parking spots in the lot. The vehicle had no front or rear plate, and had writing on the drivers side edge of the front window which suggested it may have been sold in a car auction sale recently. As we were assessing the situation the individual roused, advised he was just picking up a prescription from Walgreens and was simply tired. He showed DMV papers for the vehicle and said he had just purchased the vehicle and was waiting for his plates to be mailed to him. He did not appear intoxicated and there was no smell of alcohol or drugs from him or within the car as we spoke with him. He drove out of the lot moments after we concluded our contact with him.

- 00:25 HRS 4100 BLOCK 18<sup>TH</sup> STREET WALGREENTS LOT Parking Violation (587): As we were dealing with the previous incident, a vehicle stopped on 18<sup>th</sup> Street, effectively blocking the access ramp to the lot. CA The driver was advised and complied.
- 00:30 HRS WALGREES PARKING LOT Open Container (21): We observed two HMA's loitering in the lot, but as we approached one of the individuals advised us the other "was bothering him." There had been no loud voices or apparent argument as we approached and no signs of injuries to either party. We advised the complainant that he could simply walk away if he wished, and he chose to do so walking West onto Collingwood Street. As we inquired of the remaining individual what had happened, we noticed he had an open bottle of Hennesey's which was almost empty. We advised him of the open container law, removed the bottle and emptied its remaining contents. We advised him to leave the area and he complied.
- 00:35 HRS DIAMOND STREET & 19<sup>TH</sup> STREET Passing Call (): We conducted a passing call into this area based on a text message we received from another CCOP Patroller, regarding the earlier incident which SFPD had responded to. We checked the area for a return of the individuals who had caused the problems earlier in the evening, and conducted a flashlight search of the Harvey Milk School rear playground from outside of the fence on the Diamond Street side. No sign of the subjects on the streets or in the school was observed.
- 00:40 HRS 2400 BLOCK MARKET STREET Well Being Check (910): We observed two separate individuals sleeping on the ground in the area of the MUNI underground tunnel access point on Collingwood Street. We performed a well being check on each, and both declined medical and HOT assistance.
- 00:55 HRS CASTRO MUNI STATION Trespass (601): We observed a WMA camping on the top most garden tier of the Castro MUNI station. He was hiding in the bushes in the far North West corner. We advised him to exit the area and not return. He complied. WMA, 6' tall, thin, grey hooded sweatshirt, white t-shirt, grey baggy sweatpants and white sneakers.
- 01:05 HRS 4076 18<sup>TH</sup> STREET REVEILLE COFFEE Well Being Check (910): We observed two people sleeping on the ground in the front patio of the closed café. We performed a well being check and the WMA and WFA both declined

medical and HOT assistance. As the café did not have an MPC-25 posted we took no further action.

• 01:50 HRS CASTRO STREET & 18<sup>TH</sup> STREET – Dog Off Leash (SFHC-41): We observed a brown and white Rottweiler dog by the edge of the sidewalk in front of Wallgreens door, walking around a blanket that had been placed on the ground by a WMA and WFA. The dog had a harness, but was clearly not leashed. We asked who the owner of the dog was, and the WMA advised the dog belonged to him. We advised him about the leash laws and he produced a leash from below the blanket and attached it to the dog.
