CCOP PATROL REPORT: SATURDAY 02/21/2015 Roving Foot Patrol (RFP) Team #1 - 22:30-02:30

CONDITIONS:

Clear skies, cool, temperature in low 60s.

The neighborhood was busy early, with lines outside Badlands and the Café, but it cleared out well before last call. We started with a single team, and Dir. Hill and Ptr. Upchurch joined later allowing 2 teams of 3 persons each. Ptr. Wong will file a second report after we divided teams.

NOTABLE INCIDENTS:

- 23:14 HRS Eureka Valley/Harvey Milk Memorial Branch Library, 1 Jose Sarria Court (601) Trespass: WMA mid 30s was sleeping next to the west side of the building near the entrance. We informed him that he was not allowed to sleep next to a public building. He picked up his belongings and moved along. There was an open rolling suitcase and several objects of trash near the sidewalk entrance, which may not have been related to the 601 subject. We examined for any dangerous objects, and finding none moved some of it out of the main sidewalk and left it for the morning cleaning crew. NOTE: The MPC25 sign is the proper yellow color, but the date showed that it was more than a year old and should be replaced with a newly executed sign.
- 23:29 HRS 2344 Market Street (811) Intoxicated Person: Observed a welldressed WFA mid 20s to early 30s sitting on the sidewalk east of the Beaux bar, vomiting onto the sidewalk. She informed us that she had been ejected from the bar for being too intoxicated and was waiting for her husband to arrive to give her a ride home. While we were waiting, a WMA mid 20s in blue shirt and pants approached her. We confirmed that she knew the WMA, but that he was not her husband. We left the WMA in charge of the WFA until the husband arrived.
- 23:35 HRS Harvey Milk Plaza: DChf. Hill and SPtl. Upchurch joined our group. We split into two teams: Team #1: Carey, Dillane, Johnston; Team #2: Hill, Wong, Upchurch
- 01:08 HRS 2362 Market Street (811) Intoxicated Person: Observed 2 WFA, early 20s sitting on the curb between 2 parked cars. They informed us that they were waiting for their Uber car to arrive. Despite the appearance that both women were intoxicated, they did seem to be sufficiently sober for mutual safety until their ride arrived.
- 01:13 HRS 2330 Market Street, Streetlight Out: Observed that only 1 of the 3 lamps were lit on the top of the metal pole, resulting in a very dark area of Market Street. Used the 311 app to report the issue. 311 Request ID#: 143976
- 01:17 HRS 2308 Market Street, Additional Street Light Issues: Walking eastbound from previous location we observed that a number of other street

lights were also missing 1 or 2 of the lights in the clusters of 3 lamps. We created a 2nd 311 ticket calling out the addresses of 2310, 2301 & 2335 Market Street. 311 Request ID#: 143977

- 01:22 HRS Noe at Market Street (800/811) Erratic Behavior: A WMA, 40s to 50s was observed acting strangely on Noe Street adjacent to the building that previously housed the Industrialists store. We had earlier observed him in front of the Walgreens at Castro and 18th Street; also acting oddly. He is a known 800 in the area and is often seen acting strangely. He was kind of dancing and flailing his arms. He had his pants at his ankles, but was wearing grey long underwear, so was not exposed. We approached and asked whether he needed shelter or medical assistance. He said that he did not need either. Despite his disturbing presence, we decided he was not an immediate danger to himself or others, so left him on his own.
- 02:10 HRS 456 Castro Street (811) Intoxicated Male: Observed a WMA, mid 20s passed out next to the building. We were able to awake him and he immediately acknowledged that he was intoxicated. He was only able to give a general description of where he lived (near SF State College) and had no plans how he was going to get home. We got him to his feet and moved him to a leaning post. We called Patrol Special Police Officer Fitzinger for assistance. While waiting, the subject said he was not feeling well. We helped him to his knees so that he could vomit safely. After that had completed, we were able to hail a Yellow taxicab, confirmed that he had sufficient cash to pay the fare, and sent him on his way. We cancelled the call to PSP.
- 02:20 HRS 498 Castro Street (811) Intoxicated Male: A WMA mid 20s was leaning against the light post in front of Walgreens consuming a bag of chips. He was very disoriented. When he saw us he desperately told us that he needed to get home and could not find a cab. We turned him around and pointed out a Yellow cab that was stopped at the traffic light with his "On Duty" light lit. The driver accepted him as a fare.

NOTABLE INCIDENTS:

- 23:53 HRS Jane Warner Plaza: Caution tape was broken around the parts of Jane Warner that were supposed to be blocked off for construction and lots of people were getting caught going the wrong way, which was either making it worse or posing as a potential safety hazard. We gathered enough tape/loose ends to tie together to once again block off certain sections and direct foot traffic in the right direction.
- 23:55 HRS 2343 Market Street: No Trespass/Well-Being Check (MPC-25): BMA with wheelchair sleeping in the doorway of 2343 Market Street. We advised him that he cannot be in that doorway or any other that has a no trespassing sign in it and that he would have to get up and move his stuff. We asked if he wanted us to call any assistance for him and he declined. We waited around a little until we felt he was awake enough and starting to get up to move.
- 23:50 HRS 323 Noe Street: Well-Being Check (910): BMA sleeping in doorway wrapped in a green blanket, possibly in his 50s. There is no no trespass sign so

we ask him how he's doing and/or if he needs any assistance or for us to call anyone for him. He declines and continues catching his Zzzz's.

- 23:58 HRS 329 Noe Street: No Trespass/Well Being Check (MPC-25): WMA also around his 50s wearing a black hoodie and had a black suitcase. Sleeping in the very next doorway, except this window has a no trespass sign. So we advise him that he cannot be in any doorway where there is a no trespass sign posted and that he would have to gather his stuff to move. We ask him if he would like us to call H.O.T. for him and he declines and begins to get his belongings to leave.
- 00:13 HRS 3955 17th Street Parking Violation (587): Silver VW Beetle Lic# in a red zone near the Castro Muni F-train bay. We advised the driver, whom we weren't sure actually understood us, that he could be in the way of the train when it comes and its a red zone and that he would have to move. He acknowledged that he heard but may not have understood because he didn't immediately comply. We told him just to leave before the train arrives at least.
- 00:30 HRS Outbound Muni Shelter for #24 bus 400 block of Castro: Smoking (1009): BMA in his 60s wearing a hat smoking in the muni shelter. We asked him to put it out and he put it out on the seat next to him.
- **00:42 HRS 495 Castro Street: Smoking (1009):** WMA smoking in the doorway of 495 Castro in front of a no smoking sign. We asked him to move to the curb and he complied. Subject was wearing a suit coat and dark jeans.
- 00:44 HRS 4080 18th Street: Smoking (1009): WFA in black pants and a black leather jacket smoking on the steps. We asked her to move out to the curb and she walked away.
- 00:45 HRS 4076 18th Street: Well-Being check (910): Couple sleeping, wrapped in a blanket or 2, and no no trespassing sign posted. They confirmed that they were fine as they were.
- 00:57 HRS 194 Collingwood Street: Well-Being Check (910): Male adult, light skin, blue hoodie. Sleeping next to the tennis courts on Collingwood street. His name is
 He was pretty irritated at first with us disturbing him, but then accepted our offer to called a H.O.T. car for him.
- 01:01 HRS NW corner of Collingwood and 19th Street: Riding on sidewalk (SFTC 7.2.12): Male adult biking pretty fast on the sidewalk down 19th Street heading east towards Castro. We tried to stop him but instead yelled out for him

to get off the sidewalk and ride on the street. He complied as far as our eyes could follow him.

- 01:24 HRS 61 Diamond Street: Noise Nuisance (415): 3 AMAs being very loud. We were able to hear them almost a full block away. When we finally caught up to them, we suggested they bring their voices down and one guy said that it was his regular speaking voice. We told them that they just need to be quiet in the residential area and that maybe he should work on making his regular speaking voice quieter in general.
- 01:52 HRS T section of Hartford and 17th Street: Noise Nuisance (415): A group of black female and male adults in the middle of the street at the T section of Hartford and 17th Street yelling and making all sorts of loud noises. We flashed our lights at them and asked them to quiet down. They moved on walking east on 17th toward Noe Street saying "but this is the Castro" and continuing to be somewhat louder than necessary.
- 01:55 HRS 3977 17th Street: Intoxicated Person (811): Heavily Intoxicated HMA sick and hunched over on the ground. His friend (confirmed) WMA was helping him out and staying with him to take care of him. Soon after we approached, the HMA began to throw up in the plantar.
- 02:10 HRS 2349 Market Street: Noise Nuisance (415): A group of people that were steered away from The Cafe stopped and were being pretty loud on Market street. They were supposedly waiting for Uber so we just advised them to keep the path on the sidewalk free and to keep the noise level down. As we were dealing with this group, a guy rides by on the sidewalk on his bike. We ask him to walk it or go into the street and he did both, until he met with some friends in front of The Cafe.
- 02:19 HRS 458 Castro Street: Intoxicated Person (811): Light skin male adult heavily intoxicated passed out in fetal position in front of the doorstep of 458 Castro. He was hard to wake up but when he came to he was having trouble standing and speaking. After not too much of a response from him on whether he needed an ambulance or a cab, we called Patrol Special Police Officer Fitzinger. Soon he became more coherent and was very upset returning to reality, telling us that he had just been laid off and admitted to going overboard with the drinking that night. Eventually he did retch quite a bit, which probably was most beneficial for him to do. Our group hailed a cab for him, made sure he had enough money and knew where he was going, and sent him off. We then cancelled the call for the Patrol Special. Subject was wearing tennis shoes, a

yellow shirt, a gray hoodie, and a jean jacket and had a beard. Probably late 20s to early 30s.
