## **CCOP PATROL REPORT: FRIDAY 03/13/2015 Roving Foot Patrol (RFP) - 21:30-24:00**

### **PATROLLERS:**

### **CONDITIONS:**

Warm weather with 59 degrees and good visibility.

### **NOTABLE INCIDENTS:**

- **22:55 HRS 200 Block Noe Street & Market Street – Open Container (21):**  
Known BMA wearing black hoodie, black jeans with shoulder length hair was sitting on the flower bed wall outside of Max Muscle on the Noe Street side with an open beer can by his feet. We advised him of the open container law. He

attempted to plead that he couldn't smoke inside the bar, so he came outside to drink, but this individual is known to sit on this wall drinking beer regularly. We removed the almost full can of beer and poured it out, at which point he became verbally abusive, but ultimately decided to leave, walking North on Noe Street.

- **23:00 HRS Walgreens Parking Lot – Well Being Check (910):** WMA sleeping on the ground in a blue sleeping bag just at the entrance to the parking lot on the 18<sup>th</sup> Street side, adjacent to the Walgreens walkway. We conducted a well being check. The individual declined HOT or medical assistance.
- **23:10 HRS 100 Collingwood Street – Parking Violation (587):** Silver Nissan van, CA [REDACTED], was parked on the sidewalk, just beyond the closed parking garage gate to Mollie Stones. As we were taking down details of the vehicle, a HMA inside the garage area at Mollie Stones advised it was his vehicle and that he couldn't find anywhere else to park while he was working inside the store. We advised him he couldn't park on the sidewalk and effectively block the sidewalk. He agreed to move the vehicle to a legal parking spot.
- **23:15 HRS 100 Collingwood Street – Well Being Check (910):** WMA sleeping on the ground in a dark colored sleeping bag, on the curb side of the sidewalk. We conducted a well being check. The individual declined HOT or medical assistance.
- **23:35 HRS 2400 Block 17<sup>th</sup> Street – Trespass (601):** WMA lying on the ground in front of a parked SUV with a small white Terrier type dog, trespassing within the residence parking area. We advised him, but he declined to leave stating that the owner had given him permission to wait there until his friend came in about ten minutes who apparently worked at the liquor store next door. Not believing his story, we advised him he would have to leave. He declined again and we decided to call Patrol Special Police to assist us in removing the subject. As the call was being placed he finally decided to leave, but not before he provided a verbal barrage of profanities. As Patrol Special Police arrived on scene a few minutes later, the subject had just left the garage and was walking East on 17<sup>th</sup> Street. PSP and we elected to take no further action, but we RECOMMEND that the building management post clear NO TRESPASSING and NO LOITERING signs within the open garage space.
- **23:45 HRS Harvey Milk Plaza – Smoking ():** WMA smoking while talking on the phone in HMP. We advised him and asked him to simply walk South on the West side of 400 Castro to the sidewalk. He apologized and complied.

- **24:00 HRS Unit Block Collingwood Street at 18<sup>th</sup> Street – Faulty Streetlight ():** We reported an intermittent faulting streetlight on the North West corner of Collingwood St & 18<sup>th</sup> St to 311. Light pole number 110047191. Service number 146802.

- We made one passing call through the Castro MUNI underground station.
- We made two passing calls through the Castro Theatre parking lot, moving along some loitering individuals and observing one person just after he had urinated in public.
