NOTABLE INCIDENTS:

- **21:25 HRS Castro Street Theatre Posted No Trespass (MPC-25):** Two WMA's sleeping on the ground inside the entrance to the theatre. Conducted well being check and both refused HOT and medical assistance. We advised them of the No Trespass sign and they complied.
- 21:30 HRS Castro Theatre Security Concern (): We noticed the fire exit gate to the North of the theatre was ajar, but the theatre was closed and locked at this point, so we secured the gate.
- **21:35 HRS Jane Warner Plaza Well Being Check (910):** WMA sleeping in the North East corner of the plaza. We conducted a well being check and he refused HOT and medical assistance. As it was so windy and cold, we elected not to move him on.
- 21:35 HRS 3900 Block 17th Street Posted No Trespass (MPC-25): WMA sleeping in a private residence entranceway which had a posted No Trespass. We conducted a well being check and he refused HOT and medical assistance. We advised him on the No Trespass sign, and he complied.
- **21:50 HRS Walgreens Parking Lot Abandoned Vehicle (596):** We observed a Honda Civic CA in the North East side of the lot which had accumulated three parking tickets 3/31/15

#853500712, 4/1/15 # 853356346 and 4/2/15 #85335634. We reported the vehicle to 311 requesting that it be towed with case number # 150208.

- 22:10 HRS Harvey Milk Plaza Intoxicated Person (811): WMA sitting on the steps at the top of the stairs leading to the MUNI station, leaning against the escalator wall and sleeping. We roused him and quickly determined he was intoxicated by his responses. As we tried to determine if he could care for himself, he stood up and walked down the stairs towards the MUNI station.
- 23:10 HRS Castro Theatre Parking Lot Suspicious Vehicle (916): As we conducted one of many passing calls at the lot as the lighting in the lot is still not working, we observed a Black Honda Civic OR which Patrol Special Police Officer John Fitzinger advised he and SFPD had been looking for related to suspicious activity in the lot. We advised Officer Fitzinger that the vehicle was parked in the lot, and he contacted Mission Station to advise the relevant Officers who were interested in contacting the vehicle owners.
- **23:15 HRS 4300 18th Street Well Being Check (910):** WMA sleeping on the ground by the Post Office. Conducted a well being check and he refused HOT and medical assistance.
