CCOP PATROL REPORT: SATURDAY 04/11/2015

Roving Foot Patrol (RFP) - 23:00-02:20

CCOP Patrollers have donated a total of 444 hours to the community year to date.

SFPD OVERTIME 10b OFFICER ASSIGNED: Officer Maina Tuimavave, Star 685

CONDITIONS:

Clear skies, chilly, temperature in low 50s. There were moderate numbers of people in the streets. The crowd was well-behaved for the most part other than some loud conversations after midnight.

This 10B officer was out of the Northern Station and had never been assigned to Mission Station, so she was not familiar with the neighborhood or the nightlife. We equipped her with a CCOP radio for communications later when we separated after taking her on a walking tour of the patrol area. During the first 30 minutes we were able to introduce her to both Patrol Special Police (PSP) officers Fitzinger and Taswell. She has apparently not worked with either PSP officer in the past.

NOTABLE INCIDENTS:

- **22:50 HRS, Start of Patrol at Chevron Station, Market and Castro Streets.**
- **22:20 HRS, Castro Theatre Parking Lot 457 Castro Street, Suspicious Vehicle (917):** The lights have been repaired, and have now been lit for 2 successive nights. The suspicious metallic green Honda Civic with Colorado plates [REDACTED] was again parked in the lot. As has been the case, there was no driver around, but this time there was a small brown dog in the back seat. The car has a large amount of personal property, suggesting that someone may be living in the vehicle. It was gone from the lot by closing time at 01:00 Hrs.
- **23:35 HRS, 4100 Block 18th Street, Medics on Scene (408):** A fire engine and ambulance were parked in front of a business. The engine was just leaving the scene and the medic had their doors closed and ready to transport. We confirmed that there was no need for traffic control around the emergency vehicles. The PSP officer confirmed that a patron had too much to drink and needed medical attention.
- **23:40 HRS, Eureka Valley Rec Center (EVRC), 100 Collingwood Street, Unlocked Gates:** We found that both gates to the children's playground were still unlocked. Park Rangers have been pretty good about locking EVRC in recent weeks, but they were wide open this evening. We called Park Rangers and were told that they were running behind schedule but were on their way.
- **23:42 HRS, EVRC, 100 Collingwood Street, Trespass (601) leading to ARREST:** While working with the Park Rangers, our team located a person near the south end of the playground area. The 10B officer and team searched the rest of the playground starting at the north end to see if there were other people present. None were found, so Officer Tuimavave approached the subject and asked for identification. She radioed for a want/warrant check and was informed that the subject was a "missing person" (809) out of San Bruno, California. As she tried to get the subject to explain who may have reported him missing, she recalled the name and photograph on a bulletin in Northern Station from SID (Special Investigation Division, the SFPD officers who work with Homeland Security) that matched the identity of the subject. The officer then placed the subject into handcuffs and called for transport from Mission Station. PSP officer Fitzinger heard the radio call, and arrived to provide backup if needed. The patrol car arrived and transported the subject to Mission station for further investigation. After the subject and his laptop computer bag were safely in the patrol car, Officer Fitzinger drove Office Tuimavave back to her vehicle so that she could process the arrest. CAD#: 151013911.
- **NOTE:** The 10B officer spent the rest of her night processing the subject. She called at 01:45 HRS to tell us that she was still working with Federal officials to

determine the proper jurisdiction for the arrested individual. The 3-member CCOP team continued patrolling through end of shift.

- **00:09 HRS, EVRC, 100 Collingwood Street, Park Ranger Arrives:** The ranger arrived to lock the gates. He apologized for his late arrival and we thanked him for securing the premises.
- **00:14 HRS, 4200 Block 18th Street, Wellbeing Check (910):** A BMA, mid 30s was sitting on the steps of the residential/commercial building. He was conscious and alert. We asked if he wanted us to call the HOT van for shelter, and he informed us that he didn't like shelters because they were too dangerous and would rather take his chances on the street. He mentioned that he had some wounds on of his feet, but refused our offer to call a medic. He asked if we had any bandages, and we gave him 2 of the larger adhesive bandages from the medical kit we were carrying.
- **00:19 HRS, 18th at Diamond Streets, Found Property:** While working with the BMA in the previous incident, we found a driver's license laying on the top of the public garbage can. The license had been issued to a BFA out of Sacramento, but had expired in March 2014. We will deliver it to Mission Station in case the owner wishes to reclaim it.
- **00:27 HRS, 4200 Block 18th Street, Alcohol Container on Car:** Four people (2-AMA and 2-AFA) were getting out of a black Toyota car. There was a beer can on top of the car. When we explained that open containers were illegal they demonstrated that the can had not yet been opened. They promised not to open it, placing it back into the car.
- **00:30 HRS, Walgreens Parking Lot, Trespass (601):** A WMA, 30-45 years old was found sleeping near the front of a car parked in the northwest corner of the parking lot near the Walgreens building. We aroused him, and first checked on his wellbeing. He stated that he did not need medical attention, but appeared to be quite intoxicated. We explained that MTA does now allow trespassing in this parking lot and asked whether he was capable of walking on his own. He said he was, and proceeded to take his belongs out of the east driveway toward 18th Street.
- **00:36 HRS, Harvey Milk Plaza, Upper Level, Trespass (601):** A WMA, mid 40s to 50s was found sleeping near the retaining wall mid-block. We explained that sleeping was not allowed in the plaza. He became quite upset about having to move, but eventually did so.

- **00:38 HRS, Harvey Milk Plaza, Upper Level, Riding Bike on Sidewalk (Sec. 7.2.12):** While working with the previous (601), we noted a person riding his bike eastbound on the sidewalk in the upper plaza. We asked the rider to walk his bike, as it is illegal to ride on sidewalks. The rider complied without incident.
- **01:19 HRS, 300 Block Noe Street, Trespass (MPC-25):** An older (45-60 y.o.) WMA was sleeping in the doorway of a store, immediately beneath a MPC25 “No Trespassing” sign. We explained that it was illegal for him to sleep there. He complied.
- **01:21 HRS, 300 Block Noe Street, Trespass (601):** While walking southbound on Noe Street, we noticed a pair of legs extending out from under the debris box in front of a house being remodeled. When we shined our flashlights under the box, a single AMA, approx. 25 years of age, voluntarily crawled from under the box. He said that he thought another person was inside the box, and then proceeded to leave the area, walking southbound on Noe Street. We were unable to find anyone in the box, but later found a WMA, early 20s sleeping at the top of the steps of the house under construction. As there were no MPC25 signs posted and the home appeared to be currently unoccupied, we checked on his wellbeing and allowed him to stay.
- **01:24 HRS, Unit Block Hartford Street, Open Container (21):** Two WMA (both in their late 40s to early 50s) were sitting next to the building on Hartford Street (the building fronts on 17th Street, so does not have a street address on the Hartford side). They had quite a bit of property strewn about the sidewalk. This was not a problem except that one of the men had an open 16 oz. beer can. We explained that public consumption of alcohol was not legal, and asked that they pour out the content. Rather than comply, one of the men took the open can and hid it in his backpack. At this point one of the two men decided it best to leave, and proceeded southbound on Hartford. The remaining man became somewhat irate, so we called PSP Officer Fitzinger, who arrived in a short time. While Office Fitzinger stood by, the remaining subject packed up his belongings and left the area.
- **01:34 HRS, Unit Block Hartford Street, Open Container (21):** While walking on the west side of the street, we noted two WMA walking northbound on the opposite side of the street drinking from an open beer can. Without crossing the street, we explained that it was illegal to drink in public. They apologized and proceeded to leave the area.
- **01:41 HRS, 4000 Block 18th Street, Trespassing (MPC-25):** We found a WMA, mid 40s sitting in the area near the garbage cans for a business. The business

was posted with a MPC25 sign. We asked that the person leave, which he did so reluctantly.

- **01:40-01:55, Observe Crowds Leaving Bars on 18th Street:** We watched for dangerous conditions as the bars around Castro Street and 18th Street all moved their patrons out at “last call”. There were no apparent medical emergencies or other dangerous conditions other than people spilling into the driving lanes of 18th Street.
- **02:08 HRS, Harvey Milk Plaza, Smoking in Plaza:** Approximately 3 AMA and 3 AFA were were smoking cigarettes. We informed them that they could not smoke in the plaza, but that they could do so if they moved off of the bricked area. They explained that they were tourists and did not know the rules, and moved to the sidewalk south of the plaza.

OTHER ITEMS OF NOTE:

- **Passing Calls:** During the patrol we made passing calls at Badlands, Q-Bar, 440 Bar, and the liquor store at Market and Castro. We also made 2 checks Collingwood Park, Pink Triangle Park, and both municipal parking lots.
