### **CCOP PATROL REPORT: SATURDAY 05/30/2015**

#### **Roving Foot Patrol (RFP) - 23:00-01:30**

CCOP Patrollers have donated a total of 570 hours to the community year to date.

**CASTRO CARES 10b OFFICER:** No Officer showed up for this scheduled shift.

#### **CONDITIONS:**

54 degrees F Cold and Cloudy and clear visibility.

#### **NOTABLE INCIDENTS:**

- **23:00 HRS Start of Patrol.**
- **23:15 HRS 17<sup>th</sup> Street – Trespass (601):** The owner's wife ran out of the store to get us because the owner was having a confrontation with a patron. The owner was refusing service to someone who had caused him problems in the past. The man said he'd never been there before and that he is new to the area from out of state. This WMA is not actually new to the area. He has been spotted in the Castro before for quite some time. The patron left the store and began walking east on 17th toward Castro street later spotted on Collingwood street in

front of EVRC. The owner and the patron continued to exchanged yelling words and slurs and we kept them away from each other and moving along trying to calm them down. Once everything calmed down, we suggested to the owner that he get a "right to refuse service" sign and next time to call the police anytime he has an incident within his store. Disposition: HAN

- **23:19 HRS Castro Theatre Parking Lot – Parking Violation (587):** S HFA with short brown curly hair was reported to us by a WMA to have driven up onto the sidewalk in front of the Castro Theater. When we got there, the woman didn't seem to be going anywhere and the front of her car was on the sidewalk a good 2 feet. She drove a silver 4 door Nissan Hatchback Lic# [REDACTED] CA plate with a handicap placard. Upon our arrival she explained that she drove up onto the curb by accident and was trying to back out but the traffic passing by would not stop to allow that. With the amount of room she had, she didn't necessarily need traffic to stop but she also didn't have the car in reverse to indicate she was attempting to back up which led us to believe she hadn't intended on actually moving from where she was currently. So we stopped traffic heading north on Castro toward Market and she backed up off the sidewalk and straightened out in the parking spot. We called Patrol Special and Officer Fitzinger arrived on scene shortly to talk to her. We also made a call to 911 and a unit was sent to further access the situation. The information that we got afterward was that she was driving her sister's car and picking up her sister at the Castro Theater from the silent film festival. Apparently she wasn't use to driving the car which is why she drove up onto the sidewalk and decided to stay that way. Disposition: HAN
- **23:34 HRS 3900 Block 17<sup>th</sup> Street – Person Down (914):** Almost immediately after the police car had rolled up on the previous situation with the car, a passerby notified us of a man falling and hitting his head on the concrete next to Twin Peaks bar. We quickly headed over. The subject who had fallen was a WMA accompanied by his partner a BMA. They were both from London visiting the states and had just arrived in San Francisco from Las Vegas. The injured man was bleeding from both a gash on his right forehead and the bridge of his nose. He was heavily intoxicated and we decided to call 911 for medical assistance for him. The partner thanked us for our help and quick action. Disposition: HAN
- **23:54 HRS Walgreens Parking Lot – Loitering ():** White Ford focus 4 door CA lic.# [REDACTED]. WMA sitting in his car said he was waiting for a friend. We told him he could not be loitering in his car so he got out but he did not leave the lot so we let him wait a little longer. Disposition: ADV
- **23:55 HRS Walgreens Parking Lot – Loitering ():** MA wearing glasses sitting in his Toyota Tacoma Silver 2 door CA lic 51330M1. We advised him to leave

his car or drive out of the parking lot per the no loitering law and he soon drove off. Disposition: ADV

- **00:46 HRS Walgreens Parking Lot – Loitering ():** Same white Ford Focus from previous encounter still parked in the same spot of the lot. He thought that we meant previously that he needed to be out of his car instead of out of the lot. He said he was still waiting for his companion and that he is handicap so he cannot get out and stand or walk around. We explained the no loitering law and the reasons we enforce it and said that we would let him remain in his car but to be advised for the next time. Disposition: ADV
- **00:51 HRS Castro MUNI @ Harvey Milk Plaza – Intoxicated Person (811):** HMA passed out on the Muni steps was not responding. He was lying on his side. He was unable to speak, except for repeating Torres over and over when he was actually conscious and able to speak. We tried to rouse him awake and get him to give us any useful information but he was so out of it. We called PSP officer John Fitzinger first and then we called 911 to request an ambulance. SFFD Engine 6 responded after us followed by Paramedics in AMR#29079. They got him into a stretcher and strapped in and he was still nonresponsive. Disposition: HAN
- **01:13 HRS 100 Block Hartford Street – Well Being Check (910):** Well being check on WMA sitting/lying down on the sidewalk slightly against the building wearing black shoes and tan pants. He refused any help and services from us. Disposition: NCR
- **01:27 HRS 2300 Block Market Street – Well Being Check (910):** BFA sleeping at the entrance to the business. No sign of a no trespass sign so we asked if she was doing alright and if she needed any Medical or HOT assistance but she declined. Disposition: NCR
- **01:30 HRS End of Patrol.**
