CCOP PATROL REPORT: SATURDAY 06/06/2015

Roving Foot Patrol (RFP) - 22:30-02:15

CCOP Patrollers have donated a total of 594 hours to the community year to date.

CASTRO CARES 10b OFFICER: No Officer showed up for this scheduled shift.

CONDITIONS:

54 degrees F Cool with good visibility.

NOTABLE INCIDENTS:

- **22:30 HRS Start of Patrol.**
- **22:23 HRS 100 Diamond Street – Parking Violation (587):** White Sentra CA [REDACTED] was illegally parked entirely on the sidewalk adjacent to the school. No one was present with the vehicle. Called 311 to request DPT to handle.
Disposition: HAN

- **22:45 HRS 00 Block Diamond Street – Person Down (914):** Received a report of a person down at Diamond and Market Street. Responded to the location and searched the area but we were unable to locate anyone. Disposition: GOA
- **22:55 HRS 2400 Block Market Street – Well Being Check (910):** WMA lying in a sleeping bag adjacent to the MUNI fencing on the South side of Market Street. Conducted a well being check. Individual refused medical and HOT assistance. Disposition: NCR
- **23:10 HRS 2300 Block Market Street – Intoxicated Person (811):** Concerned citizens reported an intoxicated WMA was standing in the street trying to hail a cab. They feared he was so intoxicated he may be injured. We quickly located the individual and in chatting with him encourage him to return to the sidewalk to wait for his ride. He complied and began walking East on the South side of Market Street. He was intoxicated, but not so much that he was unable to walk or talk with us. Disposition: HAN
- **23:15 HRS One Jose Sarria Ct. – Trespass (601):** WMA and WFA with a black Labrador dog camped out on the ground immediately adjacent to the library doors. We advised them they could not trespass and they complied, walking East on 16th Street. They refused medical and HOT assistance. Disposition: ADV
- **23:25 HRS 3500 Block 16th Street – Trespass (601):** Concerned citizen advised that two homeless people had just entered a private residence garage around the corner on 16th Street. We responded and found the same WMA and WFA from the 23:15 incident. They were camping out within a covered garage entry of a private residence. We advised them they could not stay there and once again offered HOT team assistance which was refused. They walked East on 16th Street. Disposition: ADV
- **23:50 HRS 4060 18th Street – Parking Violation (587):** Observed a vehicle stopped in an area reserved for motorcycles. Advised the driver he could not wait there and he complied. Disposition: ADV
- **23:52 HRS 4000 Block 18th Street – Unsecured Garage ():** We observed a garage space next to Lark restaurant with a vehicle inside but the two large glass garage doors were laying ajar. We thought this was suspicious so entered to investigate. The vehicle had the passenger window open but otherwise the garage was unoccupied. We closed and locked the garage doors. The doorman from a nearby club advised the owner of the garage lived at [REDACTED] 18th Street and

was home, so we made contact and he thanked us for advising him and securing the garage. Disposition: NCR

- **23:58 HRS 400 Block Castro Street – Cliffs Variety Store – Posted Trespass (MPC-25):** BMA and BFA sitting in the doorway of the store with numerous items spread around the doorway. We advised them they were trespassing and pointed out the MPC-25 sign. They initially tried to claim they had permission from the store owners, but we advised that the posting of the sign indicated the owners didn't want anyone trespassing during the stores closed hours and they would have to move. We called Patrol Special Police to advise them of the trespassers and as we waited the two individuals began to move their belongings from the doorway out onto the street. Disposition: ADV
- **00:05 HRS Castro Theatre Parking Lot – Parking Violation (587):** Toyota Tacoma truck CA [REDACTED] parked in the fire lane red zone illegally. Noted the vehicle and photographed it, but did not call it in on this occasion. Disposition: NFA
- **00:20 HRS 4050 17th Street – Open Container (21):** 2 HMA's with an open container. Advised them and removed and poured out the alcohol. Both apologized and left, walking East on 17th Street. Disposition: ADV
- **00:30 HRS 100 Collingwood Street – Eureka Valley Recreation Center – Unsecured Premises ():** As we patrolled on Diamond Street we noticed the gate to the EVRC dog park was open and unlocked. As SF Park Rangers would normally close and lock the gate by 22:00 hrs, we walked through to ensure no trespassers and ensure the building was secure. One WMA left the area as we entered to walk through. The grounds were otherwise unoccupied, but we found an unsecured door to the main gymnasium on the South side of the gym. We did a walkthrough of the building to ensure no-one had entered and was trespassing within. The building was unoccupied. We called the Park Rangers to advise them of the unsecured building and gates. They advised they would respond a Ranger to secure the premises. Disposition: HAN
- **00:35 HRS 100 Collingwood Street – Well Being Check (910):** WMA sleeping in a sleeping bag on the sidewalk next to the exhaust fan for Molly Stone's. Conducted a well being check. Individual refused medical and HOT assistance. Disposition: NCR
- **00:38 HRS 100 Collingwood Street – Suspicious Person in Vehicle (916):** Green Ford Explorer with no front or rear plate and no DMV temporary

identification stickers on the windows parked as we were handling the previous incident. The owner advised he had “just bought the vehicle that day” and quickly showed us some DMV paperwork. The situation seemed a little odd, so we called the non-emergency number to report the vehicle and the BMA driver for possible follow-up. Disposition: REP

- **00:50 HRS 4100 Block 18th Street – Possession of Marijuana ():** As we were passing the LGBT history museum we observed a WMA lighting what was clearly a marijuana blunt. As we approached he quickly walked away from us and walked into Badlands. We advised the Patrol Special Police Officer on duty at the door and with the Officer entered the club and identified the individual. Patrol Special Police escorted him from the club and barred him from re-entering that evening. The individual left, walking East on the South side of 18th Street. Disposition: ADM
- **00:55 HRS 4100 Block 18th Street – Open Container (21):** BMA drinking beer from a can inside a brown paper bag outside of the flower store. We advised him, removed the can and poured out its contents. Disposition: ADM
- **01:05 HRS 300 Block Castro Street – Well Being Check (910):** WMA lying on his back next to the curb line with a guitar over his chest. We conducted a well being check and he was conscious and alert, though a little mentally off as he told us he was suffering the effects of “agent orange” and was sure he would be suffering soon, but was ok at that moment. He refused medical and HOT assistance. Disposition: NCR
- **01:17 HRS 2300 Block Market Street – Well Being Check (910):** BFA sleeping in a business doorway in a sleeping bag, surrounded by cardboard. Conducted a well being check. Individual refused medical and HOT assistance. Disposition: NCR
- **02:15 HRS End of Patrol.**
