CCOP PATROL REPORT: FRIDAY 06/12/2015 Roving Foot Patrol (RFP) - 21:30-24:00

CCOP Patrollers have donated a total of 639 hours to the community year to date.

CASTRO CARES 10b OFFICER: Officer Trullijo from Taraval Station.

CONDITIONS:

57 degrees F. Cool with good visibility.

NOTABLE INCIDENTS:

- 21:30 HRS Start of Patrol.
- 21:40 HRS 100 Diamond Street Parking Violation (587): Airstream Land Yatch XL 390 parked at the corner of Diamond Street & 19th Street with no license plates showing. Reported as abandoned as it had not moved for over three days. Reported to 311 # 4822117 who advised they must wait 72 hours before DPT will respond to it. Disposition: REP

- 22:00 HRS 400 Block Castro Street Posted Trespass (MPC025): WMA sleeping in a business doorway which has a valid MPC-25 posted. Conducted a well being check and the individual declined HOT and medical assistance. Advised and complied with the posted no trespass sign. Disposition: ADV
- 22:30 HRS 3500 Block 16th Street Well Being Checks (910): 3x WMA's sleeping on the sidewalk at the back of various businesses. Conducted well being check on all three subjects. All declined HOT and medical assistance. Disposition: NCR
- 22:35 HRS 00 Block Prosper Street Suspicious Person (917): WMA acting furtively at the front of an SUV parked in the lot on the West side of Prosper close to 17th Street. He stepped away from the SUV and sat on the edge of the planter area to tie his shoe laces as we approached and engaged him in conversation. He told us he was just "resting." We checked the area for damage to vehicles, discarded drug paraphernalia or signs of public urination, but none were obvious. We advised him of the attempted home invasion a week before, and of heightened vigilance in the area, and recommended he find an alternative location to rest. He complied leaving the area Eastbound on 17th Street. Disposition: NCR
- 22:40 HRS 00 Block Prosper Street Well Being Check (910): WMA sleeping on the East sidewalk close to 16th Street. Conducted a well being check and the individual declined HOT and medical assistance. Disposition: NCR
- 22:50 HRS Jane Warner Plaza Smoking (): 2x WMA's smoking in the Plaza. Advised and one complied immediately while the second chose to try to explain his reasoning why it was o.k. for him to smoke within the Plaza. We gently insisted and he ultimately complied. Disposition: ADV
- 22:55 HRS Harvey Milk Plaza Upper Terrace Trespass (601): WMA sleeping on the ground inside a sleeping bag in one of the cut-in areas between the planter boxes. We conducted a well being check and as the individual roused, a glass crack pipe rolled away from underneath him. We advised him he could not sleep in the plaza, and asked if he required HOT or medical assistance which he declined. He denied owning the crack pipe, gathered up his belongings and left the Plaza walking East towards Castro Street. We took the pipe to the garbage can and broke it into the garbage can. Disposition: ADV
- 23:15 HRS 4100 Block 18th Street Assault/Battery (240): As we patrolled West on the North side of 18th Street, we observed Patrol Special Police Officer

Taswell detaining three subjects and talking with two females, one HFA and one WFA. W inquired if he needed any assistance and he asked us to watch the WFA who was arguing with the HFA. We helped Officer Taswell separate the two females and we helped to detain the HMA who was standing compliantly just a few feet away from the females. We summoned the 10B Officer Trullijo to assist in the investigation. The WFA claimed to have been assaulted with unwanted touching and amorous advances by the HMA who was being detained. The HFA was arguing this point and claiming the WFA had solicited the advances. Patrol Special Police Officers Fitzinger and TJ also arrived to provide assistance during the investigation. Ultimately no arrests were made at the scene due to lack of immediate evidence or witnesses and all parties were separated and left in different directions. The WFA victim identified herself as a civilian assistant to the F.B.I. working in the San Francisco office, so the Officers had to provide their names and star #'s so she could report the law enforcement contact to her F.B.I. supervisor. Disposition: HAN

- 23:40 HRS Walgreens Parking Lot Trespass (601): HFA and HMA sitting in a parked vehicle in the North West side of the lot. We advised them of the no loitering ordinance and they agreed to leave their vehicle and walk out of the lot. Disposition: ADV
- 23:50 HRS 4000 Block 18th Street Trespass (601): As we were checking in with the door staff at "The Mix" bar on the North side of 18th Street we were made aware of some individuals sitting on the steps leading up to two private residences. Noticing an MPC-25 sign on one of the doors at the top of the stairs we were climbing the stairs towards an AMA standing at the top of the stairs. As we approached the top of the stairs the AMA advised he lived at the property, but lying in front of his doorway was a BFA who appeared to be sleeping. We roused the female who confirmed she did not live at the residence. She complied and left, walking down the stairs and the other three people who were at the bottom of the staircase left also. The AMA resident thanked us for our assistance. Disposition: ADV
- 23:58 HRS Castro Muni Station Lower Plaza Garden Trespass (601): WMA trespassing inside the gated garden on the lower plaza. We observed him as we passed through Harvey Milk Plaza on the upper level walkway. We advised him he could not trespass and sleep in the gardens and he complied, removing his belongings. He declined HOT and medical assistance, but said he may want us to contact HOT for him later that evening. Explaining we may not be around at that point, we provided him with our CCOP Resources sheet which lists shelters, food and medical locations and phone numbers. Disposition: ADM
