CCOP PATROL REPORT: FRIDAY 06/13/2015 Roving Foot Patrol (RFP) - 22:30-02:20

CCOP Patrollers have donated a total of 663 hours to the community year to date.

CASTRO CARES 10b OFFICER: No 10b Officer showed up for this shift.

CONDITIONS:

59°F, Clear visibility with no wind.

NOTABLE INCIDENTS:

- **22:30 HRS Start of Patrol.**
- **23:15 Castro Theater Parking Lot- Loitering ():** FA sitting in her car License CA [REDACTED]. The car was not on and we informed her that she was allowed to park in her car but she would have to leave the car, otherwise it is considered loitering, which is not allowed in the lot. She drove out of the lot shortly after.
Disposition: ADV

- **23:20 Intersection of Castro & 18th Street- Traffic Congestion (586):** AMA idling in the middle of the intersection seemingly waiting to turn left onto 18th street from the north half of Castro street. He was in the intersection when his light turned red, and then continued to sit there blocking all traffic for the full duration of the cross traffic light then, only after we flashed him to move, turned onto 18th heading east towards Hartford street. Disposition: NCR
- **23:23 Walgreens Parking Lot- Loitering, Parking Violation (587):** AFA sitting in the driver's side of a Silver 2 door Honda Civic in a City Car designated parking spot. Lic# CA [REDACTED]. Advised of the violation and she immediately moved out of the spot. Disposition: ADM
- **23:25 Walgreens Parking Lot- Auto Boost/Strip (852):** During our walk through the parking lot we discovered a fresh car break in. Honda Gray Odyssey 4 door van Lic# CA [REDACTED] with the rear window smashed in. We contacted non-emergency to report the break in at approx. 4122 18th street. There was glass on the ground and inside the car. We also decided to leave a CCOP note for the owner of the car mentioning that we had contacted SFPD already. Upon leaving the note on the windshield, we set off the car alarm. Soon after leaving the lot we heard a call over the police scanner regarding the car break in. Disposition: REP
- **23:32 4100 Block 18th Street - Riding Bike on Sidewalk (Sec 7.2.12):** BMA riding his bike on the sidewalk North on Collingwood toward 18th street. He rode past us at the intersection of 18th and Collingwood and we asked him to walk his bike on the sidewalk or to ride on the road. He immediately got off his bike and complied. Disposition: ADV
- **23:25 EVRC playground 100 Collingwood Street- Trespass (601):** AMA spotted sitting against the EVRC building inside the locked gates which is a no trespassing area wearing a white sweatshirt, and red and white shorts with a black beanie. We called Patrol Special Police to come get the guy out and to talk to him. We circled around the park and the school up to 19th and down Diamond street and back again to check if there were any gates opened on the other side allowing easy access to EVRC but there were none. Officer Fitzinger arrived on scene and called the guy out discovering that there were actually two MAs sleeping in the corner with their food and stuff. He got them to come out and reminded them that they are breaking a law by being in there after hours and sent them on their way. Disposition: ADM
- **23:57 2400 Market below the rainbow flag-Parking Violation (587):** Party bus teacherbus.com Lic# [REDACTED] parked in the muni bus stop on market under

the flag. We motioned for him to move so he let his passengers off in front of chevron instead. Disposition: ADM

- **23:59 Southside Underground Muni entrance- Smoking (SFHC 1009.22):** 3 WMAs smoking in front of the no smoking sign in Harvey Milk Plaza. We brought the no smoking sign to their attention and advised they go up to the sidewalk if they would like to continue to smoke. They all put out their cigarettes. Disposition: ADV
- **00:02 2400 Block Market Street- Trespass (601):** BFA was sleeping on the steps of an apartment complex. We asked if she was in need of any medical or HOT assistance and she declined. So we told her that she cannot sleep on the steps of private property and she told us that she would move and began gathering her things. Disposition: ADV
- **00:26 400 Block Castro Street- Loitering near ATM ():** WMA 20s standing right next to an ATM of Citi Bank. We advised him to not stand by the ATM unless he was using it which he clearly was not. He moved to the other side of the pillar. Disposition: ADV
- **00:38 400 Block Castro Street- Talk with citizen (909):** WMA came up to us to tell us about petty theft happening constantly and no one doing anything about it. He said that when it happened/happens, he tells the security at the business and they don't seem to care about it. We advised him that the next time anything happens that is criminal activity, to call the police and file a report. Disposition: NCR
- **00:39 400 Block Castro Street- Obstruction of Sidewalk (22):** WMA sleeping on his backpack almost directly in the middle of the sidewalk. He was wearing a black hat and jacket and blue jeans. We told him that he cannot be blocking the walkway and he moved. Disposition: ADV
- **00:47 Unit Block Hartford Street- Trespass (601):** Naked WMA sitting on private property steps in the dark. We told him that he cannot be sitting on private property and he told us that he would be leaving as soon as he catches his breath. We left and saw him walking along Market Street shortly thereafter.
- **00:52 3800 Block 17th Street- Sidewalk Hazard ():** While walking down 17th our team spotted a part of the sidewalk that was raised and a potential trip hazard. We reported it to 311 and got case ID #4825611. Disposition: REP

- **00:57 Castro Mission Health Prosper side parking- Trespass (601):** WMA sleeping in the bushes near parking lot. Right above him there was a "No sleeping/No Trespass" sign posted so we told him that he would have to relocate and sleep somewhere else. Disposition: ADV.
- **01:07 300 Block Noe Street- Well Being Check (910):** BMA sleeping in a business doorway. No MPC-25 sign posted. We conducted a well being check and asked if he needed any medical assistance or HOT team assistance. He declined any assistance. Disposition: NCR
- **01:08 300 Block Noe Street- Vandalism/Graffiti (595):** Graffiti spotted on the secondary door of 335 Noe street. We reported it to 311. Case ID #164260. Disposition: REP
- **01:19 Jane Warner Plaza- Smoking (SFHC 1009.22):** 2 separate WMAs smoking within the plaza. Both were advised and both put out their cigarettes but not without first voicing their own opinions about the law. Disposition: ADM
- **01:25 400 Block Castro street- Intoxicated Person (811):** MA spotted having difficulty walking and standing. We approached him and he was clearly very intoxicated and was having trouble on his feet as well as speaking. We talked to him while he was standing and hanging onto a tree to support and questioned him a little. From what we could understand, he was headed home and he was going to walk because he said he did not have money for a cab. We decided to call Patrol Special Police to further assess the situation. When Officer Fitzinger arrived he sat down the MA and called in for an ambulance for medical attention over his radio. The WMA tried to leave a couple of times but was in no condition to walk so we kept him there for his own safety. SFFD EMS 79 arrived and transported him.
- **01:27 400 Block Castro street- Mentally Disturbed Person (800):** During our previous incident at 01:25 a WMA 50s-60s approached our group yelling and he wedged himself between the 811 we were assisting and our group telling us to leave him alone and yelling more offensive words at us. He actually formed a fighting stance with his fists up and moved toward us. We then called 911 and explain to them that this man is threatening our group as we are trying to help the intoxicated person. He was wearing a white and black sock with no shoes, black shorts over long pants, a black jacket, and he had purple and white hair. Just as dispatch was going to take action, Jon showed up and the 800 backed down and crossed Castro Street continuing to yell at us while standing in the southbound

lane of Castro street. He eventually fully crossed and turned the corner westbound on 18th street. We explained everything to dispatch as it was happening and cancelled the call. Disposition: ABA

- **01:46 Walgreens Parking Lot- Loitering ():** BMA sitting in a blue 2 door BMW Z4 soft top Lic# CA [REDACTED]. Advised of the no loitering law and left. Disposition: ADV
- **01:46 Walgreens Parking Lot- Loitering ():** WMA and WFA sitting in a white 4 door Toyota Prius Lic# CA [REDACTED] advised to park and leave their car or drive out of the lot. Disposition: ADV
- **02:01 400 Block Castro Street- Parking violation (587):** WFA and BFA illegally parked in front of Walgreens in a red zone and also directly blocking a fire hydrant. They were driving a Silver 4 door Mazda station wagon with CA Lic# [REDACTED]. They were asked to move and complied. Disposition: HAN
- **02:16 4304 18th street- Well being check (910):** BMA sleeping in front of the post office asked if he needed any help/aid/assistance but he declined and went back to sleep. Disposition: NCR
- **00:15 HRS End of Patrol.**
