CCOP PATROL REPORT: SATURDAY 07/18/2015 Roving Foot Patrol (RFP) - 22:00-00:30

CCOP Patrollers have donated a total of 879 hours to the community year to date.

CASTRO CARES SFPD 10b OFFICER: No 10b Officer worked this evening.

CASTRO CARES PATROL SPECIAL POLICE OFFICER: TJ

CONDITIONS:

Slightly overcast skies, temperature in low 60s with light humidity and very light wind. There were moderate numbers of people in the streets. The crowd was well-behaved for the most part with more people sleeping on sidewalks than in recent weeks.

NOTABLE INCIDENTS:

•22:00 HRS Start of Patrol

• 22:06 HRS, 400 Block Castro Street, Amplified Sound (43, SFPC §2909(c)): HMA,

possibly 30, had music playing loudly from his nap-sack. After being asked to turn it off, he asked if "this was the Castro." I said "yes," and he complied by turning off the source of the sound.

- 22:20 HRS, Muni Stop, 18th St. wb @ Castro St. (CVC §22500(i)): Silver Nissan Sentra parked in Bus Stop. Advised 2 HWA occupants who complied by leaving the bus stop.
- 22:28 HRS, Castro Theater Parking Lot (601): Jeep Liberty CA **SYVX178** contained several FA occupants that seemed to be loitering. I advised all occupants of MTA parking rules and they complied by leaving the lot.
- 23:02 HRS, 500 Block Castro Street, Sidewalk Obstruction (22): I advised a WFA, possibly in her late 30s, who was sitting in the middle of the sidewalk that she was obstructing pedestrian traffic and should move to the inside of the sidewalk. She complied by moving accordingly.
- 23:20 HRS, 4200 Block 19th St., Harvry Milk Academy, Trespass (601): We advised a WMA, possibly in his 60s, who was sleeping in the inset of the western entrance right below a clearly posted 'No Trespassing Sign" that he couldn't stay there. As he gathered his copious belongings, he became somewhat belligerent, muttering and yelling various phrases, which included a phrase to the effect of "I'm going to hang myself." We called SFPD (CAD# 151994034), and unit arrived in about 10 minutes. The 2 officers had a drawn out conversation with the WMA, during which they essentially advised him to move along peacefully without further threats of self-harm or he would be arrested but that his belongings would be left behind. The WMA grudgingly complied and moved along.
- 23:30 HRS, 100 Block Collingwood St, EVRC, Trespass (601): A WMA, possibly about 30, was found milling about the dog park and asked to leave. He compiled. Three BMAs of indeterminable ages were sleeping along the back wall of the EVRC building. They were roused by our presence and likely by the conversation we had with the WMA. Two of the BMA left on their own, and we asked the third to leave, advising him that the park was closed. He complied by leaving, though slowly so. We contacted the Park Ranger to report that all gates to the EVRC complex were open. The ranger answered and said he was on his way to close the gates and would be there shortly. We saw him a short time later closing the gates, thanked him and chatted with him briefly.
- 23:35 HRS, 4300 Block 19th St., Car Alarm/Suspicious Vehicle (916): A Ford Explorer CA **SFBU/86** with alarm sounding and open passenger door caught our attention. We and identified ourselves and explained our concern to the occupants in the rear of the vehicle, a WMA, possibly in his late 20s, and WFA,

They explained that they weren't the owners but had come with the owners who were at a party nearby, and that they (the WMA and WFA) had come back to the car to get some items when they triggered the alarm. We took a picture of the WFA's CA DL (Asha Yasmin Syeda Karim, DOB 1995-09-15, #E3427588).

- 23:45 HRS, Wallgreens Parking Lot, Trespass (601): A WMA, possibly 30, was sleeping in the corner of the parking lot. We advised him of the MTA rules, he complied by packing up his sleeping gear and left.
- 23:50 HRS, 400 Block Castro St, Open Container (21, CB&PC §25620(a)): We confiscated a 16oz open container of beer from WFA, possibly in her late 20s. We advised her of the open container law.
- 23:54 HRS, Jane Warner Plaza, Amplified Sound (42, SFPC §2909(c)), Several BMAs and WMAs were near a device amplifying music. They were collectively advised of the city city ordinance and complied by turning off the device. Within minutes they had turned on the sound again, but as they were also leave the plaza at that point, no further contact was made.
 - 00:20 HRS, 4300 Block 19th Street, Residential Noise (415, SFPC §2909(a)(1)): We asked that one of the several adults in standing on the steps of a house clearly have a loud party to close front door to reduce noise. They initially complied by closing the door, but the door quickly opened again and remained open, prompting the team to return and again request that the door be closed and kept closed. The second request seem to work, as they complied by closing the door, after which we didn't hear any further significant noise as we walked away from the residence for the second time.

OTHER ITEMS OF NOTE:

Passing Calls: During the patrol we made passing calls at Badlands, Q-Bar, 440 Bar, Edge, Beaux, Castro MUNI Metro, and the liquor store at Market and Castro. We also made checks of Collingwood Park, the Library on 17th and Pond, and both municipal parking lots.
