# CCOP PATROL REPORT: SATURDAY 07/24/2015 Roving Foot Patrol (RFP) -21:30-24:00

**CASTRO CARES SFPD 10b OFFICER:** 10b Officer Jeremiah Swangler worked this evening.

**CONDITIONS:** 

Mostly clear skies, moderate, temperature in mid-60s with light winds, good visibility. There were moderate numbers of people in the streets. The crowd was well-behaved for the most part.

#### NOTABLE INCIDENTS:

#### •21:52 HRS Start of Patrol

- **22:00 HRS, NE corner of 18th & Castro:** Met up with 10b Officer Jeremiah Swangler. Introductions made all around.
- 22:05 HRS, 4000 block of 18th St between Castro and Starbucks, met up with Hoodline editor: Brian Ray, who accompanied us for most of patrol.
- 22:15 HRS, 4000 block of 18th St JEO Starbucks, accident: Lit cigarette landed on Ptlr. Fullagar's shoulder as team walked East on north-side sidewalk. Brushed off by Ptlr. Nguyen. No injury or property damage. Source uncertain, presumed to be tossed from upstairs window.
- 22:25 HRS, Parking lot behind Castro Theatre, suspicious circumstance: WMA at back of parked vehicle, hatch open. He stated that he was trying to locate a noise at the back of the car. Team members assisted him with their flashlights in inspected the undercarriage. He drove away.
- 22:35 HRS, Municipal parking lot off 18th St behind Magnet, vehicle break-in (459): Ford Explorer, California license **TREP332**, found parked in lot, right-front window smashed and glass on ground and on seat of car. No other damage apparent, glove box closed but contents apparently dumped on floor. Report made to SFPD (non-emergency) and note left for vehicle owner.
- 22:50 HRS, 3500 block of 16th St opposite Pond, camping on sidewalk (MPC 22): Six MAs, four inside tent (it was more like a two person tent,) two outside. Advised to move on. Complied after some reluctance.
- 22:55 HRS, Library parking lot at 16th St and Pond, trespass (MPC 25): MA. long brown hair, sleeping on ground next to library building. Advised. Patrol Special, called about this and next incident, responded.
- 23:00 HRS, Library parking lot at 16th St and Pond, trespass (MPC 25): Dark colored Chevy Blazer. Washington license AUR8177, parked in

lot. Personal property on roof of vehicle, one person sleeping inside. Patrol Special, called about this and previous incident, responded.

- 23:15 HRS, 3985 17th St (Hearth) between Castro and Hartford, trespass (MPC 25: Couple bedded down in doorway. Current sign posted. Advised to move on. WMA said they would comply. A few minutes later other half of couple, possible WFA, introduced herself as
  Iffenvil and stated that she sleeps there every night. When PtIr. Fullagar pointed out that she was not there the previous Friday night, she stated that she "must have been at the club or something." She then stated that she has an understanding with Hearth and Patrol Special. Upon our query, Patrol Special stated that this is not the case, and he would respond.
- 23:17 HRS, Jane Warner Plaza, smoking (HS 104495): Smoker advised. Complied.
- 23:29 HRS, 470 Castro, public consumption of alcohol: Group of 12-15 young adults, mixed gender and race, sitting on sidewalk singing with (one) ukulele. One was drinking 40 oz. beer. Advised, beer disposed of.
- 23:40 HRS, Eureka Valley Rec Center, premises not secured: Two pedestrian gates (on Collingwood) and vehicle gate (on Diamond) found not merely unlocked (as they had been the week before) but standing open. Building apparently secure. No persons found on premises. Park Patrol notified.
- 23:50 HRS, NE corner Diamond St & 19<sup>th</sup> St (by ball field,) Welfare check: MA in sleeping bag next to fence. Awakened, and was then responsive and declined assistance. (Same individual as previous week.)
- 23:55 HRS, Diamond St JNO 19<sup>th</sup> St (by ballfield,) possible found property: WMA asked who we were and, upon hearing Castro Patrol, stated that he found one of our cameras in his store. He identified himself (verbally, no documentation) as a "federal operative," supervising "12-15 agents." He offered to go get the camera from the store but Chief Carey (who has spoken with this individual previously) declined the offer as we were not missing any.
- 23:56 HRS, 4316 19<sup>th</sup> St, welfare check: WMA sitting on steps of residence (down from sidewalk, to service alley or rear unit,) feet bare, boots and socks sitting on step beside him. Although sitting upright, he was barely responsive at first, only turning his head or responding audibly (though not intelligibly) after repeated attempts to get a response from him. A call to Patrol Special asking whereabouts of 10b officer resulted in both Patrol Special and 10b responding. Asked by the 10b if he had ID, the individual responded that it was in his bag, which he believed to be nearby.

Team searched the immediate area (street to front of houses, two houses to either side) and found no bag. Interview with neighbor revealed that the subject does not live at that address, but may have some connection with occupants of lower unit. Ambulance requested by 10b, who also dismissed Team.

**Passing Calls:** During the patrol we made passing calls at Muni Metro station,17th/Noe Market, and KD's Market at Market and Castro. We also made checks of Collingwood Park, the Library on 17<sup>th</sup> and Pond, and both municipal parking lots.
