- 22:07 HRS, Castro theater parking lot: Loitering (): Dark colored Volvo SUV CA lic# 757R050 parked in the lot turned off with a WMA I the drivers seat. We approached, flashed our lights and the driver quickly exited the lot. Disposition: GOA
