CCOP PATROL REPORT: FRIDAY 08/28/2015
Roving Foot Patrol (RFP) - 22:00-01:00

CASTRO CARES SFPD 10b OFFICER: A 10B officer was in the neighborhood, but we did not have a chance to meet him because of the many incidents.

CONDITIONS:

High humidity with temperatures in the mid 60s. There were relatively large numbers of people in the streets. The crowd was well behaved for the most part with more people sleeping on sidewalks than in recent weeks.

NOTABLE INCIDENTS:

•22:12 HRS Start of Patrol

- **22:16 HOURS, Citizen Report of Agitated person (909/917):** WMA addressed us from a car stopped in the intersection of Collingwood and 18th, that a WMA was harassing and threatening pedestrians in the area of 19th & Castro near Buffalo Whole Foods market. At the same time Chf. Carey heard a call for service at 19th and Collingwood, which may have been related to the report. We contacted DChf. Hill by radio and he said he would meet us at the location.
- **22:20 HOURS, Buffalo Whole Foods 598 Castro, Wellbeing Check (910):** We found a 28 y/o WMA, who may have been the person reported by the citizen, on the corner outside 590 Castro St., rifling thru the trashcan. Upon questioning him we learned he used to live in SF five years prior and had walked from Monterrey to San Francisco. Currently homeless with possible mental health issues. WMA also admitted he was under the influence of meth. He said he was yelling at people because he "thinks people have plans to get him." Brian offered shelter, which the subject accepted. Brian to contact HOT but was advised that they no longer take requests for shelter from the public and we would need to contact SFPD. He called 311 and ended up talking to the same HOT person who insisted that we were not authorized to request service. After being advised of his options re HOT, WMA said he would wait for the Police. He then called non-emergency, and the dispatcher was surprised that HOT would not accept our call, and called HOT and were given a 45 minute ETA for the van to arrive. We called Patrol Special who was equally as surprised of this new process. Two PSP officers arrived on scene and were briefed of the situation. We told the subject of the ETA and he said he would wait for the van.
- **22:51 HOURS – 4000 Block 19th Street, Intoxicated Person (811):** AMA 34 Y/O 19& NOE spotted on Castro street heading East on 19th St. AMA appeared to be inebriated as he stumbled along the sidewalk and occasionally wandered into the street. We caught up to him for a wellbeing check. Asked if he needed any assistance in getting home. He replied he does this a lot and lived just 2 blocks away. He promised that he would be OK and thanked us for our concern for his safety.

- **22:58 HOURS, Noe at 18th Street, Wellbeing Check (910):** - 2 homeless WMA'S sitting on the sidewalk up against KASA at 18th & Noe. Well being check. Refused HOT services.
- **23:05 HOURS, Castro Theatre Parking Lot, Blocking Driveway (586):** - Uber driver, License Plate [REDACTED] Blocking Castro Theatre Driveway while waiting for fare. Driver moved when asked.
- **23:08 HOURS – Castro Theatre Parking Lot, Trespass (601):** 2 WMA's - employees from Dapper Dog sitting in their vehicle ([REDACTED]) on break, "about to leave." Advised of parking lot restrictions.
- **23:11 HOURS, Castro Theatre Parking Lot, Answered question:** - WMA approached and asked about Castro Theater parking rules.
- **23:13 HOURS, Jane Warner Plaza, Litter Removed (33):** - Removed a blanket that was hanging atop a potted tree along the western edge of JWP.
- **23:39 HOURS – Walgreens Parking Lot, Trespass (601):** - BMA & WFA mid 30s with a wheeled suitcase were found in the northeast corner of the lot. Advised of no loitering restrictions and they left the area.
- **23:41 HOURS – Walgreens Parking Lot, Trespass (601):** - 2 WFA's sitting in white Dodge Charger advised of parking lot restrictions. They left immediately afterwards.
- **23:42 HOURS – Walgreens Parking Lot, Auto Break-in (852):** Freshly broken glass was on the ground next to a silver Toyota, which had a broken passenger window. There were miscellaneous items visible within the vehicle. We called non-emergency to register the time of the discovery and left a note on the windshield instructing the owner to call the police to file an official case.
- **00:02 HOURS – Café Bar, 2369 Market Street, Intoxicated Person (811):** HMA early 30s acting belligerent and combative because he was refused entrance to the Cafe Bar. HMA had been detained by Police earlier for causing a scene on Castro Street and making pedestrians feel uncomfortable. He was advised by SFPD to "behave" otherwise they would be called again and have to arrest him. Doorman at Cafe dismissed his presence. Chf. Carey explained that if the bar staff refused his entry, he could not enter or they would risk their license. After talking with CCOP the subject proceeded East down Market Street.
- **00:18 HOURS - 2306 Market, Wellbeing Check (910):** WMA - Refused HOT assistance.

- **00:39 HOURS - La Taqueria at 495 Castro St. Trespassing (601):** - WMA sitting in doorway of restaurant while it was still open for business. CCOP asked him to move along and not sit in doorways blocking entrance for customers. Subject proceeded South on Castro Street.
- **00:40 HOURS – 18th at Castro Street, Reckless Driving, Noise Nuisance (415):** 2 HMA's in a two door black compact car license plate [REDACTED], squealing tires and peeling out in intersection at 18th & Castro. After getting their attention with flashlights, they drove westbound on 18th Street at a reasonable pace.
- **00:42 HOURS - Bank of America 501 Castro Street, Trespass (601):** 3 WFAs and 1 HMA were having conversation while sitting on the concrete wall opposite the ATMs. Advise group no loitering in the area of an ATM. Group shouted obscenities as they left the area walking westbound on 18th Street.
- **00:50 HOURS – 4255 18th Street, Wellbeing Check (910):** WMA & WFA sitting on steps of apartment building at 18th & Diamond. WMA appeared to be sleeping or passed out as he was lying sideways on the steps and WFA was scrolling away on her smart phone. While doing a well being check upon hearing us address WFA, WMA immediately sat up that he was just tired and they were waiting for an UBER. Thanked us for our service.
- **01:00 HOURS, END OF PATROL**

OTHER ITEMS OF NOTE

During the patrol we made passing calls at Noe Hill Market on 19th S), 711 (18th & Noe), Badlands, 440, Beaux, The Mix & Cafe Bar. We also made checks of Collingwood Park, the Library on 17th and Pond, and both municipal parking lots.
