# CCOP PATROL REPORT: FRIDAY 09/11/2015 Roving Foot Patrol (RFP) - 23:00-02:00

**CASTRO CARES SFPD 10b OFFICER:** A 10b Officer was scheduled to work, but no-one showed up.

#### **CONDITIONS:**

Cool with temperatures in the low 60s.

### **NOTABLE INCIDENTS:**

#### •23:05 HRS Start of Patrol

- 23:20 HRS, 498 Castro Street Well Being Check (910): WMA sitting on the ground hunched over. At first it was unclear to us if he was conscious or not, but as we approached we realized he was awake, but was intoxicated on something. He refused HOT and medical care and advised he was fine. Disposition – NCR
- 23:25 HRS, Jane Warner Plaza Open Container (21): Multiple mixed race youths in the North West corner of the plaza with open containers. They finished the beer as we approached but discarded the empty bottles in the planter bushes of the plaza. We advised them of the open container law and asked them to properly dispose of the bottles. They willingly complied. – Disposition – ADV
- 23:26 HRS, Harvey Milk Plaza Sleeping (SFPC 3/13): BMA sleeping in one of the alcoves on the upper level wrapped in a sleeping bag. We conduced a well being check and the individual refused HOT and medical assistance. We advised him he could not sleep in the plaza, but we was welcome to remain and sit in the plaza provided he remained awake. He complied. Disposition – ADV
- 23:35 HRS, 18<sup>th</sup> Street & Castro Street Intersection, Public Report (909): A WMA approached our team to tell us not to hassle the homeless. We advised that we checked on their well being and offered them assistance if needed, but this did not satisfy him. Disposition – NCR
- 23:40 HRS, Walgreens Parking Lot Entrance 18<sup>th</sup> Street, Assault (240): The same WMA from the previous incident (identified by one of our team members a second of team members a returned on three occasions to accost our team as we waited for another team member to join us. During these tirades he verbally advised he was a "member of the I.R.A. and that he was going to kill" Deputy Chief Craig as he identified him from his accent as British. DChf. Craig advised the subject he was being audio and video recorded and had just committed a offense for which he could be detained in the hope the threat of detention would encourage him to leave. We knew SFPD was busy handling three shooting incidents around the city and did not want to bring them in for what we did not consider a very serious or likely threat. After a few more warnings the individual finally left the area. Disposition ADM

- 23:53 HRS, 18<sup>th</sup> Street & Castro Street Intersection, Skateboard on Sidewalk (SFTC 7.2.12): WMA passed between our team and some other pedestrians riding a skateboard at high speed from Castro Street, turning West on 18<sup>th</sup> Street on the sidewalk. He returned about a minute later still riding the skateboard on the sidewalk and a high rate of speed approaching the same corner. We stopped him physically and he initially became non-compliant and verbally threatened to physically assault DChf. Craig and DChf. Hill. We explained why we physically stopped him as he presented a real danger to the safety of pedestrians on the sidewalk and that it was illegal to ride his skateboard on the sidewalk. Disposition – ADM
- 00:05 HRS, Noe Street & 17<sup>th</sup> Street Intersection, Report (909): JMA approached our team to advise us of an incident that had occurred earlier in the evening and to update us on the suspect descriptions for the two individuals involved in the incident. The incident had been transmitted earlier in the evening as a 917 suspicious persons and SFPD had responded to the scene. We passed on the new information to Patrol Special Police Officer Fitzinger. Disposition HAN
- 00:10 HRS, Pond Street & 17<sup>th</sup> Street, Well Being Check (910): WMA sitting by the entrance to the closed medical center. We conducted a well being check and he advised he was fine, just resting. He refused HOT and medical assistance. Disposition NCR
- 00:12 HRS, One Jose Sierra Court, Trespass (MPC-25): Numerous individuals were sitting or lying and sleeping in the car park area of the library. We advised them of the MPC-25 No Trespassing sign and the majority of the individuals complied and began to pack up their belongings to leave. Two individuals were unwilling to be roused, so we called the Patrol Special Police for support and Officer Fitzinger arrived on scene within a few minutes. All subjects ultimately complied, refusing HOT and medical attention, but we distributed some Castro Cares information cards to a few of those willing to take them. Disposition – HAN
- 00:30 HRS, Jane Warner Plaza, Medical Situation: As we responded to JWP on the report of a vehicle injury accident, hit and run, we observed a WMA sitting on the sidewalk by Twin Peaks bleeding from a laceration to his upper lip. We asked if he was o.k. and he advised he had been petting a dog in JWP when it suddenly attacked him. We observed Medic 71 arrive on scene and flagged them down to provide assistance to the injured individual. Witnesses in the area advised that the injured party was intoxicated and had indeed been petting the dog without incident, but then acted strangely and the dog had reacted by snapping at him. They believed it was not a vicious dog, nor an attack, but merely the dog

responding to the individual. Subject was taken into the care of the SFFD Medics. Disposition – HAN

- **00:55 HRS, 4100 Block 18<sup>th</sup> Street, Intoxicated Person (811):** AMA standing in the street next to a parked vehicle with his back to traffic, throwing up. We approached to inquire if he needed medical attention, but he seemed fairly alert and composed. A WMA on the sidewalk in the area approached and advised he knew the AMA and would ensure he got home safety. The AMA confirmed knowing the WMA. Disposition NCR
- 00:57 HRS, 4100 Block 18<sup>th</sup> Street, Safety Concern: We observed a number of people inexplicably sitting on the road immediately behind parked vehicles on both sides of 18<sup>th</sup> Street by the Magnet location and by the Historical Museum. We advised all that for their safety, they should remain on the sidewalks, especially as the night wore on and some drivers may not be paying as much attention as expected. Disposition – NCR
- 01:00 HRS, Walgreens Parking Lot, Driving Under Influence (CVC21200): WMA sitting in a Blue BMW CA with the engine running, but asleep. It took numerous attempts to rouse him and it appeared he was intoxicated. We advised him that simply having his keys in the ignition of a vehicle when he is intoxicated could be grounds for a DUI charge. He denied he was intoxicated advising he had only had four hard liquor drinks that evening, but he seemed clearly intoxicated to us. We advised him to leave his vehicle in the lot for the evening and take a taxi home. He complied reluctantly. We later noticed the vehicle was no longer in the parking lot. Disposition – ADV
- 01:05 HRS, Walgreens Parking Lot, Trespass (601): JFA in a Blue Ford Explorer CA had been advised when we passed through the lot earlier that she could not loiter in her vehicle. She remained in the vehicle and was making no effort to leave, so we called Patrol Special Police for assistance. Officer Fitzinger arrived a few minutes later, just as she decided to finally gather up her belongings and leave the vehicle. Disposition – ADV
- 01:20 HRS, 4100 Block 18<sup>th</sup> Street, Unlicensed Vendor (): We observed a hot dog vendor outside of the closed Magnet Store on the North side of 18<sup>th</sup> Street. The vendor advised he did not have a permit, so we advised him he had to shut down his grill and leave the area. We stood by as he loaded his equipment into Purple mini-van CA
- 01:27 HRS, 444 Castro Street Posted Trespass (MPC-25): Two WMA's, one being the skate boarder from earlier in the evening, were sitting in very close proximity to the Citi Bank ATM's and directly in front of the posted MPC-25 No Trespassing signs at the bank. We advised them,

and they asked if they could sit on the edge of the sidewalk instead. We advised that would be fine and they complied. Disposition - ADV

- 01:35 HRS, 2300 Block Market Street, Intoxicated Person (811): As we patrolled East on the North side of Market Street we notices an AMA outside of Beaux Bar who appeared very agitated and was shouting quite loudly. The security officer at the bar asked if we could assist in moving him on. We advised him that the staff was refusing him entry and that if he continued to make so much noise he may be in danger of being arrested for being drunk in public. He became even more agitated and demanded his sober friend to "record everything." Nothing we did seemed to settle him down so we called for Patrol Special Police support. Officer Fitzinger arrived on scene within a few minutes and was able to calm the individual down and persuade him to leave the area. Disposition HAN
- 02:00 HOURS, END OF PATROL

During the patrol we made passing calls at Badlands, 440, Beaux, The Mix & Cafe Bar, the Library on 17th and Pond, and both municipal parking lots.
