CASTRO CARES SFPD 10b OFFICER: A 10b Officer from PARK station was on duty.

CONDITIONS:

Warm with temperatures in the low 60s. Good visibility with no precipitation.

NOTABLE INCIDENTS:

•23:00 HRS Start of Patrol

- **23:05 HRS, One Jose Sierra Court Public Library – Well Being Check (910):** WMA sleeping on the ground beside a parked vehicle. We conducted a well being check and the individual refused HOT and medical assistance. Advised on the posted MPC-25 and he complied, gathering his things to leave. Disposition – ADV
- **23:25 HRS, Castro Theatre Parking Lot – Trespass (601):** Two WMA's loitering in the parking lot as they spoke with each other. Advised of the no loitering ordinance and they advised they were just about to leave. Disposition – ADV
- **23:30 HRS, Walgreens Parking Lot – Trespass (601):** BMA sleeping on the ground in front of a parked vehicle. We conducted a well being check and the individual refused HOT and medical assistance. We advised him of the no loitering ordinance and he complied and began to gather his things. Disposition – ADV
- **23:40 HRS, Harvey Milk Plaza, Smoking (191):** Advised a few people who were smoking in the plaza of the ordinance prohibiting smoking. All complied by leaving the plaza. Disposition – ADV
- **23:50 HRS, 2320 Market Street, Well Being Check (910):** WMA sleeping on the ground in the doorway to a closed business. We conducted a well being check and the individual refused HOT and medical assistance. Disposition – NCR
- **23:51 HRS, 2310 Market Street, Well Being Check (910):** BMA sleeping in the doorway of a closed smoke shop. We conducted a well being check and the individual refused HOT and medical assistance. Disposition – NCR
- **00:05 HRS, Market Street @ Sanchez Street, Open Container (21):** JMA crossing the intersection drinking from an open bottle of beer in a brown bag. Advised him of the open container laws and he complied by surrendering the beer which we poured out. Disposition – ADM
- **00:25 HRS, 100 Collingwood Street, Well Being Check (910):** BMA & WMA sleeping on the ground by the tennis courts. We conducted a well

being check and both individuals refused HOT and medical assistance.
Disposition – NCR

- **00:26 HRS, 19th Street @ Diamond Street, Well Being Check (910):** WMA sleeping in a sleeping bag on the ground by the baseball field. We conducted a well being check and the individual refused HOT and medical assistance. Disposition – NCR
- **01:05 HRS, 4076 18th Street, Suspicious Person (917):** BMA observed acting suspiciously within the closed seating area in front of the closed Reveille Coffee store. We contacted the individual who advised he was just looking for somewhere to sit. We advised him as the store was closed and the seating area was closed and roped off, that he was trespassing. He complied and left the area. Disposition – ADV
- **01:25 HRS, Jane Warner Plaza, Smoking (191):** WMA smoking in the plaza. Advised and complied. Disposition – ADV
- **01:30 HRS, 444 Castro Street, Intoxicated Person (811):** WFA sitting on the ground in front of the ATM's who had thrown up on the ground and was now sitting in the vomit. She was conscious and able to speak with us, but was "muddled" initially telling us she was visiting San Francisco from San Francisco. We finally ascertained she was visiting from Boston and staying at a guest house on Bryant Street. We called Patrol Special Police and Officer Fitzinger arrived within a few minutes. The subject advised she was with an Indian male friend who was in the Q-Bar club, so we checked with the security at the bar, however they advised she was on her own when she entered and left the bar. We determined she was sober enough to make her own way home, and she had her wallet, so we helped her hail a cab and sent her on her way home. Disposition - NCR
- **02:10 HRS, 3946 17th Street, Urinating in Public (153):** JMA was cautioned not to urinate in public next to the Subway sandwich shop on Market Street after he left the nearby club and was told to use the public restroom or an alternative nearby restroom. Suspecting he would not comply, we followed him around the corner onto 17th Street and sure enough he stepped into a doorway and began urinating against the door. When we approached again he became dismissive and obstructive, so we called for Patrol Special Police assistance. Officer Fitzinger arrived moments later, and the on duty 10B SFPD Officer drove up a few moments later also. CA DL [REDACTED] Ruiz Rodriguez Gael Humberto was admonished by the 10b Officer, as she did not witness the urination herself a citation was not possible. He was advised to leave with his husband and friend or face arrest for public intoxication. Disposition - ADM

- **0220 HRS, Castro Street Theatre Parking Lot, Urinating In Public (153):** BMA urinating against the fence on the South side entryway to the lot. We admonished the individual and apologized, promising not to do so again. Disposition - ADM
