**CONDITIONS:**

The weather was cool and overcast with temperatures in the low 50's.

**NOTABLE INCIDENTS**

- 11:30 - Start of patrol from MCC.
- 11:36 - 518 Castro Street. BMA sleeping in the doorway - Trespassing (MPC-25) Refused HOT services. Well being check (901) Advised of city ordinance, subject slowly moved along.
- 00:09 - 4149 18th St - Edge Bar - 2 - HMA's - Assault (240) possible Hate crime. Heated confrontation between the suspects and two bar patrons. SFPD had the suspects detained in front of Eureka Valley Recreation Center. Provided Traffic control at intersection of 18th & Collingwood.
- 00:27- Castro Theater Parking Lot. Trespass (601) 2 HMA eating in vehicle. Dark blue SUV (CA: [REDACTED]). Advised of loitering/trespass law. left after manually starting the vehicle.
- 00:31- Jane Warner Plaza - BMA sitting on the north wall/flower bed smoking (SFHC 191) Advised him of the no smoking ordinance, subject complied and steadily moved along.
- 00:34 - 2355 Market St. Coldwell Banker - Real Estate Office. Well being check (910) WMA sitting on the window sill, refused HOT services.
- Two champagne bottles were visible in his left front jacket pocket. Advised subject of open container law. He explained it was urine, not alcohol. We walked with him to public toilet near Chevron to dispose of it properly. It was occupied so walked him to the storm drain at Castro & Market St., corner with Pottery Barn. He poured it down drain and thanked us for our assistance.
- 00:51 - 30 Collingwood St. Private Residence. 1 HMA 1 WFA Homeless encampment tarp tied to tree. Trespass (601). Advised to please remove or we would remove it . WMA readily complied.
- 01:00 - Muni Stop ID# 13339, 18th & Market St. HMA appeared to be intoxicated (811) but roused on approach, stated he was just resting his eyes; waiting for the #33 bus. Well being check (910)
- 01:03 - 498 Castro St. Walgreens. WMA Agressive Solicitation (120) At first glance it appeared panhandler had an open container in his bag. DChf Hill explained public domain gives us reason to question him. He immediately became irate spouting profanities, swearing in full patronization. We proceeded North on Castro St while WMA continued to speak obscenities.
- 01:05 - 444 Castro St. Citibank Posted Trespassing (MPC-25) requested to please move along, citing loitering law. Refused services, complied and moved along without incidence. Well being check (901)
- 01:10 - 426 Castro St. Rossi's Deli WMA Sitting in doorway Posted Trespassing (MPC-25) subject hesitated until we advised we would contact PSP. He reluctantly obeyed our request.
- 01:16 - 3583 16th St. Starbelly Restuarant - MMA scavenging recyclables and cardboard from the Recovery waste management receptacles. Driver did not lawfully have right to be operating said vehicle. (white Chevrolet pick up truck) no valid/visible license plate. Upon driving off a slightly visible (CA) license plate was seen tied to the trucks

front grill.

- EVHMM Library - 1 Jose Sierra Court WMA - Trespassing (601) Advised needed to vacate, citing loitering law. However, he refused to leave. PSP wasnt available. #311 as a precaution. Subject eventually left without incidence. CAD# 160302931
- 01:29 - Super Duper Burger (SFCL-A) Traffic Code - Section 100 - HMA barreled down the sidewalk on a skateboard. Attempted to advise however the noise of the wheels careening down the sidewalk drowned out the message.
- 01:35 - 3600 16th St. Lookout Bar Doorman/Security, Steven, requesting assistance regarding an intoxicated person. (811) HMA apparently hit his head while tumbling down the stairs. He vehemently refused our assistance. He proceeded East on Market St. coming to rest on a bench on the sidewalk. Reiterating our assistance, he again refused and haphazardly jogged back to the Lookout. After a careful indepth inquiry he agreed to take a cab home. DChf Hill flagged down a taxi while Steven had been upstairs preparing an ice pack. Thanked driver for stopping. The cab drove away.
- 01:37 - 3600 16th St. Lookout Bar. WMA approached us in the crosswalk, obviously inebriated. Intoxicated Person (811) too drunk to walk home. Requested assistance. DChf Hill flagged down a cab where he was whisked away to his warm waiting bed.
