CCOP PATROL REPORT: SATURDAY 01/31/2016 Roving Foot Patrol (RFP) - 11:00-13:45

CONDITIONS:

The weather was clear and sunny with temperatures in the upper 50s.

NOTABLE INCIDENTS

- 11:00 Hrs, Start of Patrol from MCC
- 11:30 Hrs, Jane Warner Plaza, Smoking (SFHC 191): WMA sitting at one of the tables smoking. Advised him of the no smoking ordinance and he complied. DISPOSITION: ADV
- 11:40 Hrs, 2223 Market Street, Well Being Check (910): WMA sleeping in a doorway wrapped in aluminum foil. Conducted a well being check and the subject asked to be taken to a shelter. We called HOT and provided his location and description. DISPOSITION: HAN
- 11:58 Hrs, 2223 Market Street, Well Being Check (910): WMA who had been sleeping
 in the doorway to the closed business just a little away from Danile began to gather his
 belongings. We conducted a well being check. Subject declined HOT and medical
 assistance. DISPOSITION: NCR
- 12:05 Hrs, 2420 Market Street, Intoxicated Person (811): BMA sleeping on the ground next to the MUNI entrance on the North side of Market Street. A small dog was clearly agitated and was "protecting" the BMA. We attempted a well being check, but the subject was largely unresponsive so we called for EMT assistance. While we waited a member of the public advised he had also called about the person, and reported that the dog had "snapped" at numerous people who were passing. A MUNI worked advised us that the dog almost bit her also. SFFD Engine 6 arrived on scene and we assisted in securing the dog to allow them to work on the subject. King America ambulance 328 arrived shortly after. The subject was transported along with his dog which had settled down considerably. CAD# 160311521. DISPOSITION: HAN
- 12:25 Hrs, 2420 Market Street, Lost Property (): As we completed the prior incident, an AMA and AFA approached to advise they were trying to locate the females "lost" i-phone and her handbag with her ID in it. The "find my i-phone" application suggested it should be somewhere very close, but they had not reported the loss of either the phone or handbag to police. The advised it was lost the prior evening. We advised them to give up their own search and to report the loss to police. Unfortunately the AFA had not recorded her phones serial number or IEMI number so the chances of recovery are slim. DISPOSITION: HAN
- 12:30 Hrs, 2420 Market Street, Civil Sidewalks (168): The owner of the liquor store at
 the location of the prior two incidents asked if we could help move along a WMA who was
 sitting on the sidewalk outside of her business. We asked if he needed HOT or medical
 assistance which he refused. We then advised him he would have to move on, and he
 grudgingly complied. DISPOSITION: ADV
- 12:35 Hrs, 4120 18th Street, Urinating in Public (153): BMA sleeping on the ground by
 the edge of the sidewalk. Conducted a well being check. Subject refused HOT and
 medical assistance. He then got up and walked into the Walgreens lot and immediately
 began to urinate against the fence. We admonished him and advised him to use the
 public restroom at Castro and Market instead. He grudgingly acknowledged our
 recommendation. DISPOSITION: ADM
- 13:05 Hrs, 476 Noe Street, Well Being Check (910): WMA laying on his back sleeping
 on the sidewalk under the shade of a tree. We conducted a well being check and he
 advised he was just "resting." DISPOSITION: NCR

- 13:20 Hrs, 2 Hartford Street, Well Being Check (910): WMA standing with his
 possessions under the scaffolding on the West side of Hartford, who appeared to be
 acting strangely. We approached to conduct a well being check, but as he approached he
 became aware of us and engaged with us. Advised he needed something to eat, but
 declined to allow us to call HOT or medical for him. Provided him with Project Homeless
 Connect card and advised him to call them to connect to services. DISPOSITION: NCR
- 13:25 Hrs, Jane Warner Plaza, Well Being Check (910): 2x WMA, one limping badly
 while the other supported him passed us in JWP. We inquired if they were o.k. and if they
 required medical assistance, but they both refused. DISPOSITION: NCR
- 13:35 Hrs, 4092 18th Street, Aggressive Solicitation (120): WFA and WMA sitting on
 the sidewalk close to Starbucks who were shouting at passers by to give them money
 and calling after people who passed them by. Cautioned them that such conduct could be
 considered aggressive solicitation which was illegal. The WFA was the main instigator
 and she quickly apologized. We offered them HOT or medical assistance which they
 declined but we did provide them with the Project Homeless Connect card, and a sheet of
 resources. Patrol Special Police also attended the scene while we were talking with the
 pair. DISPOSITION: ADM
