**NOTABLE INCIDENTS**

- 11:15 Hrs, Start of Patrol

- 23:16 - 4131 19th St. Private Residence - BMA Peering into car. Upon noticing us he walked back to his illegally parked vehicle (CA-██████████) blocking the sidewalk, where his accomplice was waiting. 2 DOOR SEDAN Dark colored
- 23:18 - 532 Castro St. Ayala Real Estate - As we approached BFA was squatting over a newspaper in the doorway. Slightly perturbed she adamantly refused any advice including HOT i.e. Mentally disturbed person (800) BMA continued on in this manner as she gathered her belongings, slowly making her way North on Castro. DChf. Hill contacted #311 to verbally note the incident. CAD# 160364300
- 23:32 -Phantom - 516 Castro St. Member of the Public Report (901) - the clerk at Phantom advised us about recurring shoulder surfers at ATM - peeping pins.

Hill. Crowd immediately dispersed.
