CONDITIONS:

The weather was clear with temperatures in the upper 50s. The crowd was relatively small for a Saturday night especially considering it was Super Bowl weekend. This was Trainee Pascale's first patrol.

NOTABLE INCIDENTS

23:00 HRs, Start of Patrol at 150 Eureka Street

23:33 HRs, Castro Parking Lot, Trespass (601): A white car (CA: [REDACTED]) was parked in the lot with 2 LMA occupants in the car. We explained that the lot was posted against remaining in the automobile after parking. The occupants stated that they were waiting for a person who worked in an adjoining business and that they would leave within 10 minutes. We allowed them to stay, with the note that we would be checking later. As we were approaching the next incident, the 2 occupants were seen leaving the lot.

23:42 HRs, Castro Parking Lot, Trespass (601): A second vehicle was similarly occupied in the driveway of the parking lot. It was occupied by 2 AMA and 1 AMJ who was sleeping in a child seat the back seat. We explained the trespass rules. They explained they were waiting for the manager of the sushi restaurant across the street to finish work. We again allowed them to remain until their rider was off work.

23:52 HRs, Bank of America 501 Castro, Wellbeing Check (901): A known mentally challenged (800) BFA (5'4" slender build, bushy hair) was sleeping next to the Bank on a skateboard for a pillow. We awoke her to check on her wellbeing. She immediately rose to her feet and walked away, refusing services.

00:26 HRs, KD Liquor 2416 Market St Littering (33): The owner of the store reported that a BMA, had taken some of the content of the garbage bin at the corner of Castro and Market Streets and strewn it about the sidewalk. We located the BMA subject (medium build, average height, medium long curly hair, mostly unclothed) sitting next to 17th Street a short distance from the store. He was sitting in what appeared to be his own urine next to a roller bag type suitcase. We asked if he needed assistance or medical care, and he refused service, even though he did seem to be mentally distressed. He did not seem to be eligible for a 5150 call. We did admonish him about the littering, which he claimed he had not done. (Later discussions with SFPD Officer Lattig confirmed that it would be difficult to 5150 him under the able to care for himself clause, as doing so required that he be turned over to someone willing to care for him, and no one was available in that capacity. We asked that the daytime HOT team attempt to make contact.)

00:31 HRs, Harvey Milk Muni Plaza, Intoxicated Individual (811): Two citizens were coming up from the Muni station and told there was someone passed out in the corner of the plaza who needed attention. We found an LMA about 40 years old sitting on the cinder block wall. After a little effort we were able to rouse him. He did not appear to be homeless (915) but was very disoriented. We were able to get him to tell us that he lived in the east-bay and that his intention was to take BART home. BART was closed by this time. He then said he would take Uber, but when we asked him about his cell phone, which he would need to summons Uber he produced a wallet, but no phone. His backpack was open and we helped him reclaim some of his clothes. The Muni operator said he had been in the plaza since about 10 PM and provided him with an all-night Muni ticket so that he could get to Embarcadero for a better chance of catching a public transport. He went down to the platform. However instead of getting on an in bound train, he sat on the bench until the last Muni train had left the station. He then proceeded to walk back to Castro Street under his own power.

00:57 HRs, Harvey Milk Muni Plaza, Trespass (601): As we were patrolling at Castro and 18th Streets, we received a phone call from the Muni operator. She informed us that she found a person sleeping on a bench on the platform as she was locking the station. She had notified SFPD but felt they would take a long time to respond. We located a 915 AMA about 40 who appeared to be unconscious on the bench. We could not get him to wake and were ready to make a 911 call for medical assistance when he suddenly woke up. We explained that Muni was closed for the evening. He refused medical help and walked out of the station under his own power.

01:15 HRs, Walgreens Parking Lot, Intermittent Light (311 Case): The light on the pole in the northeast corner of the lot was intermittent. This same light had been the subject of a previous 311 case (#5496624) which had been moved to "Closed". We used the APP to open a second case: #5543269

01:30 HRs, Bank of America 501 Castro Street, Possible Shoulder Surfers: Ptlr. Wong recognized 2 individuals who have been seen lurking around both the Bank of America and the CitiBank ATM areas for several weeks. There is a high likelihood that they are fraudulently obtaining cash from unsuspecting ATM customers. We attempted to get video footage to possibly identify them. One was a tall, slender BMA with a baldhead, and the second was a shorter LMA (about 5'6") with a stocky build. We remained in the area until first the LMA and then the BMA left the area.

01:43 HRs, 499 Castro Street, Illegal Parking: An Uber car was stopped in the red zone next to the fire hydrant. We asked the driver to move along, which he did.

02:05 HRs, Chevron Parking Lot 2399 Market Street, Fight or Dispute (418): After the Café closed, a WMA, thin build, average height, mid 20s in a red jersey with white lettering was seen making threatening gestures to the window on the west side of the filling station. Moments later a BMA, tall, thin wearing a yellow jersey approached him and made threatening gestures toward the first person. Three of the bar security approached and the BMA left the scene. The WMA remained and made threatening moves toward the staff. PSP Officer Fitzinger joined and one of the bar employees asked the WMA whether he wanted to be arrested. At first he indicated that he didn't care, but looking behind him he saw the 4 of us in orange ready to assist. He decided to leave, and was last seen running eastbound on 17th Street.
