### NOTABLE INCIDENTS

Start of Patrol 19:00

- 19:12, 119 Collingwood, Meeting with a citizen (909)- A woman stopped us in front of the edge after realizing we were Castro Patrol and asked us to go talk her husband into joining as she has been trying to convince him. We walked up a couple houses to 119 Collingwood and met with the couple, Chf. Carey gave him a card and explained that the next training class will be on March 15<sup>th</sup> and that he should come and give it a try. Disposition: NCR
- **19:25, 495 Castro street, Intoxicated person (811)-** HMA on his knees hunched over a pile of vomit. His friend, an HFA said he was okay and actually is doing pretty good compared to other nights and that he just ate. Disposition: NCR
- **20:09, Walgreens parking lot, Loitering ()-** WMA sitting in his car, a Silver 4 door BMW CA Lic# **CA Lic**# **CA Li**
- 20:16, 25 Collingwood, Suspicious person(s) (917)- One BMA and one WMA holding a gate to a residential home open while opening a delivered package on the doorstep. We approached and asked if they live there and he confirmed that he did and that he was just showing his partner his new jacket. We explained that it was a little suspicious the way he was opening the package on the porch while not actually in or out of the gate. He seemed a little peeved at first but he thanked us for being vigilant and acknowledged that he was aware of Castro on Patrol. We suggested next time maybe not Disposition: ADV
- 20:22, street between Chevron and Muni F cable car stop, Wellbeing check (910)- 2 WMAs, one sitting up, the other lying on the ground. We went over to check on them and asked if they were doing ok and if they needed any medical attention or H.O.T. The two confirmed they were okay and not in need of any services. Disposition: NCR
- 20:25, 2399 Market St/Castro Chevron Station Public restroom, Meeting with city employee (905)- Don, a city employee working on the public restroom asked to talk to us and waved us over. He wanted to talk to us about possibly keeping an eye out for people going into the public restroom for other things besides using the toilet. He mentioned increase graffiti and vandalism inside. He gave us the name and number of his supervisor to call if we do witness anything or have any information. The name is Rodrigo (operational manager) who can be contacted at <u>415-871-1250</u>, or directly at <u>415-871-9850</u>. We explained to him that Andrea from CBD would be the one to get in contact with about issues they may have and that she has been working on a solution as well and that we would of course keep an eye out for anything suspicious still. Disposition- NCR
- 20:35, West side of Pottery Barn 300 block of Castro St, Wellbeing Check (910)- Tall WMA lying down and talking to himself. We approached and asked if he was okay. He got up as we asked him if he needed any medical attention and he said no and walked away while still mumbling to himself. Disposition- NCR
- 20:36, same as previous incident, Meet with Citizen (909)- At the tail end of the previous incident, a WMA approached us to inquire about castro patrol. He asked us questions about if we carry mace, and how do we protect ourselves, and what do we do exactly..... Chief Carey spoke to the gentleman and answered all of the questions he had and then the man walked off while wishing us luck. Disposition: HAN
- **21:05, 4128 18<sup>th</sup> Street, Wellbeing Check (910)-** BMA sleeping in the doorway of Dr. Blair Keck DDS with a blanket. We roused the man and asked him if he was doing okay, or if he needed medical or HOT. He denied all and went back to sleep. Disposition: NCR
