CCOP PATROL REPORT: SATURDAY 02/27/2016 Roving Foot Patrol (RFP) -21:30-24:00

CONDITIONS:

The weather was clear with temperatures in the upper 50s. The crowd was average for a Saturday night, but well-behaved by the midnight ending time. This was Trainee Reiss' and McLaughlin's first patrol.

NOTABLE INCIDENTS

21:30 HRs, Start of Patrol at 150 Eureka Street

- 21:53 HRs, 532 Castro Street, Wellbeing Check (910): BFA was found sleeping in the doorway of a merchant on Castro Street. The entry was not posted with an MPC-25 sign. We woke her to confirm that she was physically well. She refused medical or shelter options.
- 22:13 HRs, Eureka Valley Library, 1 Jose Sarria Court, Trespass (601): We noticed that there were no tents along 16th Street across from the library, but that there was a single orange tent pitched next to the library entrance. This was the day that the City has disbursed the tent encampment along Division Street, so we expected that there may have been an increase of activity. We decided to not contact the occupants of the tent because of 1) The possible political fallout from the Division Street event and 2) The library had agreed during the open meetings about improving safety to provide some type of official security service for their property. We did check the remainder of the grounds and found no campers in the parking lot or in the area behind the building.
- 22:51 HRs, Harvey Milk Plaza, 400 Castro Street, Noise Nuisance (415): 5 WMA in their mid 20s, with pseudo-nun makeup were dancing in the area between SoulCycle's front door and the bike racks with a loud boom box. An event was in progress at the Castro Theatre which had brought in a number of drag performers. We explained the city ordinance about amplified sound, and reminded them that there were residences near by and it was after 10 PM. They apologized and turned off the music.
- 23:03 HRs, Harvey Milk Plaza Muni Station, Trespass (601): We noted a person sleeping in the garden area next to the Muni platform. He was behind a tree next to the retaining wall on the northern part of the garden, so was barely visible from the sidewalk. We shined our lights and got his attention and explained that he was not allowed to camp on Muni property. He came out of the area and a second person appeared who had also been in the same area. They both climbed over the iron fence and exited toward Castro Street. The first was a WMA about 50 year old, and the second was a WMA in his 20s with a short brown beard.
- 23:07 HRs, 29 Collingwood Street, Wellbeing Check (910): A WMA, mid 20s was sitting on the steps of the residence. We asked whether he lived there and he replied that he did not. We asked whether he needed medical help or shelter for the night and he refused both services. He promised that he would move from the steps after he got a bit of rest.
- 23:10 HRs, Walgreens Parking Lot, Trespass (601): Two BMA in their late 20s or early 30s were sitting in the back seat of a car parked on the eastern side of the parking lot. The windows were tinted, so we did not notice them when doing our first inspection. There appeared to be holes from buckshot on both the driver's door and the left-hand rear door. We explained that the City did not allow loitering in the lot after parking a vehicle. They informed us that they were aware of this rule, but that their buddy was inside Walgreens picking up a prescription. We told them we would ordinarily ask them to leave, but would allow them to stay for a few minutes until their associate(s) returned. Plate: CA
- 23:28 HRs, 501 Castro Street, Bank of America, Possible Shoulder Surfers: Two men, 1 WMA and 1 BMA, in their late 40 to 50 years, were seen hanging out in front of

the ATM plaza at the bank. The BMA was pretending to repair his bicycle, and the WMA was a few feet away. Both men had backpacks. PSP Officer Fitzinger was parked near by and said that he was observing them as possible ATM shoulder surfers. (NOTE: This is a different pair than we observed the in the report from 6-FEB-16 which also had photos.) They left the area after noticing the 5 CCOP members talking with PSP. (Low quality photos captured)

- 23:45 HRs, Castro Theatre Parking Lot, Trespass (601): 2 vehicles were occupied in the lot. The first was a red SUV (CA: 4EIP118) with 3 people standing outside the vehicle smoking. They told us they were waiting for the performance in the Castro Theatre to let out so that they could remove rented audio and lighting equipment. We explained the City policy about loitering and they voluntarily left the area until the show ended. A second vehicle (CA: 7PMZ114) was also occupied. The subjects said they were leaving soon.
- 23:58 HRs, Citibank, 444 Castro Street, Trespass (601): The blond street person "Patrick" was acting strangely (800) next to the after-hour-depository at the north end of the bank property. We explained that he was not allowed to be there, and he pointed to the expired MPC-25 sign. We then pointed out that he was next to the deposit device and that was no allowed. He then agreed to move out of the area. He continued to act strangely, but thanked us for our service.
