CCOP PATROL REPORT: SATURDAY 03/19/2016 Roving Foot Patrol (RFP) - 23:00-02:25

CONDITIONS:

The weather was clear with temperatures in the lower 50s. Very light precipitation at the very beginning of the patrol, but his abated within a very short time and it remained dry for the remainder of the patrol.

NOTABLE INCIDENTS

23:00 Hrs Start of Patrol

- 23:20 Hrs HARVEY MILK PLAZA Wellbeing Check (910): HMA sleeping on the ground in one of the alcoves on the upper level walkway. Successfully roused but refused HOT and medical assistance. Advised of the Plaza rules regarding sleeping and the subject agreed to comply. DISPOSITION: ADV
- 23:33 Hrs CASTRO THEATRE PARKING LOT Loitering (): CA WMA and AMA sitting inside the vehicle. Advised of the no loitering ordinance and they complied, driving out of the lot. CA WMA sleeping in his vehicle. Advised of the no loitering ordinance and indicated he would comply. DISPOSITION: ADV
- 23:40 Hrs 18TH & CASTRO INTERSECTION Indecent Exposure (311): A member of the public advised us of a BMA dropping his pants to show off his penis at Hibernia Beach. As we waited to cross at the red light, we observed the BMA dropping his pants

and underwear, clearly displaying his penis. We cautioned him and at first he argued that other people "walk around naked all the time." We admonished him again and advised that if he repeated his action we would summon Police to cite him. He reluctantly agreed to comply. DISPOSITION: ADM

- 00:01 Hrs 4109 18th STREET Open Container (21): HMA observed with an open can
 of beer. We advised him of the city ordinance and asked him to pour out the beer and
 properly discard of the can. He complied. DISPOSITION: ADV
- 00:05 Hrs 496 CASTRO STREET Suspicious Person (917): WMA observed looking into a parked Mercedes vehicle in a very suspicious manner. Subject appeared to be "high" on something, but capable of walking. We asked if he was the owner of the vehicle to make him aware of our presence and he responded "yes" but after another look into the vehicle he left, turning West on 18th Street. We followed and found him standing next to the MUNI bus shelter. We observed him for a few moments and determined he was not a major threat at this point. DISPOSITION: NCR
- 00:10 Hrs 430 CASTRO STREET Parking Violation (587): We observed a small Fiat
 vehicle parked illegally in the red bus zone with its hazard lights activated. As we began
 to investigate a BFA returned to the vehicle, apologizing. We advised her of the fines
 automatically sent as a result of cameras in many MUNI buses and of the disruption
 caused by parking in such locations. DISPOSITION: ADM
- 00:13 Hrs 410 CASTRO STREET Well Being Check (910): BMA lying across the
 seats of the MUNI bus shelter asleep. We conducted a well being check and the subject
 refused HOT and medical assistance. Advised him he could not sleep in the shelter as it
 prevented other people from using the seats. He grudgingly complied. DISPOSITION:
 ADM
- 00:20 Hrs 375 CASTRO STREET Well Being Check (910): WMA sleeping on the ground in a fire exit alcove of the Pottery Barn premises. We conducted a well being check and the subject refused HOT and medical assistance. DISPOSITION: NCR
- 00:25 Hrs 2344 MARKET STREET Unlicensed Vendor (): HMA hot dog vendor outside of Beaux Bar. We inquired if he had a sellers permit. He advised he did, but he didn't have it with him. We advised he would have to leave but he could return with his permit. He complied. DISPOSITION: ADV
- **00:40 Hrs 73-79 POND STREET Light Out ():** Observed that the building light remains out on the corner of the Department of Public Health building at 17th Street.
- 01:10 Hrs 18TH STREET & CASTRO STREET Jay Walking (21955): We observed a WMA who was clearly "high" on something, standing in the on-coming Westbound lane of 18th Street in the Castro Street intersection with East/West traffic having the green light. The subject was well outside of the marked crosswalks, swaying back and forth and paying no attention to traffic on the roadway. We advised him to return to the sidewalk for his own safety, which he did. DISPOSITION: ADV
- 01:12 Hrs 451 CASTRO STREET Intoxicated Person (811): We observed a BMA go
 to the ground by the sidewalk on the opposite side of Castro Street as we were dealing
 with the Jay Walking incident above. The subject got back up and began to "hug" the light
 pole. We approached and inquired if he was ok at which point a WMA with him advised
 he would help to get him home. The BMA confirmed the WMA was his husband and they
 were just waiting for their UBER ride. DISPOSITION: NCR

- 01:26 Hrs EUREKA VALLEY RECREATION CENTER Trespass (601): HMA sleeping
 on the disabled access ramp between the dog park and the gym. We conducted a well
 being check and the subject refused HOT and medical assistance. Advised him that the
 park closed at 10 PM and he would have to leave. Subject complied. DISPOSITION:
 ADV
- 01:35 Hrs EUREKA VALLEY RECREATION CENTER Unsecured Perimeter (): We called SF Park Patrol to advise them that the perimeter entry gates around the center had not been secured yet. They advised they would notify the on-duty Officer. DISPOSITION: NCR
- 01:36 Hrs Approx: 198 COLLINGWOOD STREET Well Being Check (910): WMA sleeping under some blankets on the EVRC side by the wall below the dog park.
 Conducted a well being check. Subject refused HOT and medical assistance.
 DISPOSITION: NCR
- 02:00 Hrs 2344 MARKET STREET Unlicensed Vendor (): Same HMA from the 00:25
 Hrs incident had returned and was selling hot dogs once again. We admonished him and
 stood by as he dis-assembled his stand and left. DISPOSITION: ADM
- 02:10 Hrs CASTRO THEATRE PARKING LOT Loitering (): Group of mixed race and gender individuals standing in the lot chatting. We advised them that the lot officially closed at 1 PM and of the city ordinance against loitering. They apologized and complied. DISPOSITION: ADV
- 02:12 Hrs 470 CASTRO STREET Posted Trespass (MPC-25): WMA sleeping in the
 entrance to the AEF STRUT building which has a properly posted MPC-25. Conducted a
 well being check. Subject refused HOT and medical assistance. Advised of the no
 trespassing sign and subject complied. DISPOSITION: ADV
- 02:15 Hrs 18TH STREET & CASTRO STREET Reported Vehicle Fire (528): As we were walking back to MCC to demobilize we saw two SFFD fire trucks responding code 3 who stopped at the intersection of 18th & Castro. Over our scanners we heard a report of a maliciously set vehicle fire and a suspect description. We approached the SFFD personnel and advised we had not seen any vehicle fire in the area. We searched the Walgreens parking lot, but no fire noted. Suspect it was a malicious hoax call. DISPOSITION: UTL
- 02:20 Hrs 4109 18TH STREET Noise Nuisance (415): Group of mixed race and gender individuals making a lot of noise by the flower store. We asked them to keep the noise down as they were in a residential neighborhood. They complied and left the area. DISPOSITION: ADV
