CONDITIONS: No 10-B officer on duty. Clear and cold 53 degrees F.

NOTABLE INCIDENTS:

- **23:24 Shift on 17th Street. Well being check (910)-** BMA sleeping against the Shift building. Wearing jeans and red jacket. We woke him and asked if he was in need of medical attention or shelter. He declined services but asked for a blanket. We were going to give a mylar space blanket to him but we did not have anymore in the medical bag. **Disposition: NCR.**
- **23:29 Harvey Milk Plaza. Smoking in park (SFHC 191)-** BMA yelling and smoking in Harvey Milk Plaza. We asked him to keep his voice down

and to smoke outside of the bricked surface which indicates Harvey Milk Plaza. The individual complied. **Disposition: ADM.**

- **23:47 468 Castro Street. Dog off leash (41)-** WFA and WMA sitting in front of 468 Castro Street with a dog that was not attached to its leash. We asked them to keep the dog restrained and to also clean up their trash before leaving. They put the leash on the dog and we continued after thanking them. **Disposition: ADM.**
- **23:51 444 Castro Street. Posted no trespass (MPC-25)-** BFA playing piano in front of Citi bank. We first asked her to turn the volume down on the keyboard and then noticed the no trespassing sign in the window. We told her that she cannot be in front of this business because they have a no trespassing sign posted in their window. She argued and said that the police don't bother her when they walk by and see her playing the keyboard in that same spot. We told her that she'd have to move at least out to the sidewalk and she began to pack up her things. **Disposition: ADV.**
- **23:58 2343 Market Street. Posted no trespass (MPC-25)-** WMA in a wheelchair eating. We asked him if he needed any medical assistance and he declined. We then told him that he would need to move to a different spot that didn't have the posted no trespass sign in the window or he would have to move at least out to the sidewalk. He said he would move when he finished eating so we moved on. **Disposition: ADV.**
- **00:18 Eureka Valley Library. Posted no trespass (MPC-25)-** 8 people with a dog in the doorway of the library where there is a posted no trespass sign. We asked them to leave that spot because of the sign and they complied moving slowly to pack up all of their belongings. **Disposition: ADM.**
- **00:36 Castro Theater Parking Lot. Parking violation (587)-** We noticed a VW beetle car in the driving lane at Castro Theater parking lot blocking movement in both directions. It was on and there was a HFA in the passenger seat. We asked her to move the car and told her that they were blocking the traffic. She claimed to not know how to drive the car and said that her boyfriend was inside sliders getting food. He finally came out and we told him that he could not park like this and there were much better options that to block the traffic in and out of the parking lot. Lic# [REDACTED]. **Disposition: ADV.**
- **00:43 Jane Warner Plaza. Smoking and Alcohol (21)-** We noticed two WMAs smoking in Jane Warner Plaza. When we walked up to them and asked them not to smoke in the plaza we then saw that they also had beer cans in the planter beside them. ADChf. Hill asked them to throw them

out along with the other trash that they had around them. **Disposition: ABA.**

- **00:57 Eureka Valley Library. Well-being checks (910)-** There were a lot of people sleeping on the steps of the Eureka Valley library parking lot steps. 2 WMAs, 1 WFA, and 1 BMA who all seemed to be separate. We woke each person up to make sure they were okay and ask if they needed medical attention or shelter for the night. They all refused and went back to sleep. **Disposition: NCR.**
- **01:09 17th street and Noe street. Trash on the sidewalk (33)-** We put in a ticket for a 311 issue. We found a trash can overturned with the contents scattered all over the sidewalk. Our 311 case# was 6928479. **Disposition: HAN.**
- **01:15 Ford and Noe streets. Well-being check (910)-** We walked up on a homeless couple with a wheelchair. WMA and WFA and asked them to pick up their trash. They ended up leaving the spot altogether. **Disposition: NCR.**
- **01:44 The Mix. Traffic backed up/double parkers(587)-** We noticed that traffic was backed up on 18th street heading west back to the stop sign at Hartford Street. When we went to look at what the issue was, we saw one car that was double parked in front of The Mix and traffic consistently coming down east on 18th. We shined our light at the Lyft driver and told her that she could not just stop right there and hold up traffic behind her. So she ended up moving and then immediately after she left another car pulled up and did the same thing. We also shined our light at him but his Uber passengers were just getting in. He left and traffic finally returned to normal. **Disposition: HAN.**
