CCOP PATROL REPORT: SATURDAY 04/29/2017
Roving Foot Patrol (RFP) 21:30-24:00

CONDITIONS: Clear night, good visibility, 57 degrees with a slight breeze

NOTABLE INCIDENTS:

- **21:48 - 500 Castro St - Well Being Check (910)** As we approached the intersection of **Castro Street** and **18th Street** we observed a **WMA** transient sitting against **Harveys Restuarant**. He was holding a sign in a non aggressive attempt to panhandle and engage passersby. Since his legs were blocking the sidewalk we asked him to move. We engaged in short conversation with him regarding his well being and any services he might need. **WMA** politely declined and we proceeded **Eastbound on 18th Street**.

- **21:55 - Private Residence - 4000 Block 18th Street** - As we approached the intersection of **Hartford & 18th Street** we noticed a silver four door toyota corolla attempting to back out of the driveway. We assisted by stopping traffic to safely guide driver into the Westbound lane of traffic. Driver thanked us for our assistance as we continued on patrol.
- **22:01 - 7-11 3998 18th Street - Uber driver BMA 4 door Black Toyota** blocking fire hydrant directly in front of the store. Driver screamed profanity after he was asked three times to move his vehicle. Driver yelled "You guys take your jobs way to seriously." It was at this moment driver stepped on the gas and made a sharp U-turn repositioned his vehicle on the opposite side of the street. Driver proceeded to get out of his vehicle yelling epithets as he went into the store. We did not engage as we shuffled safely past this incident.
- **22:14 - Private Residence - 00 Block Pond Street Well Being Check (910) 2 WMA's** sitting on the ground in front of residents garage door. Subjects engaged us as we approached but refused services including our suggestion to move from the property. One of the men exclaimed they had permission to be there. We've encountered this before in previous patrols which we usually dismiss. Nevertheless they thanked us for our service and also for checking on their well being as we continued **Northbound on Pond Street** .
- **22:30 - CVS Pharmacy 2280 Market Street - Well Being Check (910) BMA** sitting in front of entrance to store sifting through his belongings that were strewn about the pavement. He said he was just resting and didn't need services.
- **22:45 - Posh Bagel 495 Castro Street - Well Being Check (910) WMA** refused services.
- **22:55 - Castro Theatre Parking Lot - (MPC 25) Trespass - 3 WMA'S** sitting in their vehicle advised they were charging their phones before respectively going about thier business in the Castro bars. Advised of city ordinance, subjects happily complied.
- **23:00 - Castro Theatre Parking Lot - (MPC 25) Tresspass - Well Being Check (910) WMA** - as we approached 2 dogs were barking loudly as The Team observed a homeless man sleeping in the far West corner of the lot. He refused to move so we advised we would be coming back around to check on him and if needed we would get assistance to move him along.
- **23:05 - Hot Cookie - 407 Castro Street** - As we walked Northbound on Castro Street past the Castro Theatre we noticed the line for Hot Cookie was blocking the sidewalk. We kindly asked the patrons to form a single file next to the building as to not block the pedestrian flow of traffic. We also took this opportunity to engage a few about the patrol by handing out safety whistles and literature.
- **23:15 - Walgreens Parking Lot - (MPC 25) - Noise/Nuisance (415)** There was a flutter of activity here. Besides the usual comings and goings of vehicles there was a WMA rummaging through the contents of his vehicle. A red two door Ford Bronco with its speakers blaring rock music. We advised of the noise disturbance as well as no loitering ordinance. There was also a WFA looking though a pile of trash that was dumped in one of the empty parking spots.
- **23:24 - Walgreen Parking Lot (MPC 25) - WMA** sleeping in car. **Illinois License Plate [REDACTED]** We aroused him by knocking loudly on the window. Subject appeared to be under the influence perhaps sleeping off his head change. (The keys were not in the ignition) as we inquired further he explained he was "waiting for his friend to return with the keys," however seeing as this is likely just a detractor to get us to move along

we stood firm in our position. We contacted **Patrol Special, John Fitzinger** who arrived within minutes. He advised that "it was crazy out tonight." To "choose our battles wisely since there were only four cars out in the Mission." After a few questions it was determined that he was OK to remain in his car.

- **23:35 - 495 Collingwood Street** - Citizen approach to advise that three cars were broken into the night before. Before we could get a word out he immediately cut us off and walked across the street to engage the Ranger who had come to check the gate at Eureka Valley Recreation Center.
