## CCOP PATROL REPORT: WEDNESDAY 05/03/2017 Roving Foot Patrol (RFP) 23:00-00:30

**CONDITIONS:** Clear and not too cold until the temperature began to drop after midnight.

## NOTABLE INCIDENTS:

 23:00 400 Block of Castro Street. Suspicious package (531)-There was a suspicious package/device called in to SFPD reportedly in the 400 block of Castro street which prompted our last minute guick setup of a patrol. Police had roads blocked off at 16<sup>th</sup> street and Castro headed South, Castro and 18<sup>th</sup> street headed North, Diamond and Market headed East, and Noe and Market headed West. The incident happened before 10 and was not resolved until about 23:30.

- 23:03 Diamond and 19. Street. Litter (33)- WMA with lots of items and trash scattered on the sidewalk. We approached him and asked him if it was all his stuff. He said yes and the he was sorting through it and separating recyclables and trash. We asked him that when he finished up that he make sure and pick everything up after himself. He agreed and we continued on our way. Disposition: NCR
- 23:07 538 Castro. Well-being Check (910)-WMA sleeping in the doorway of Dogo love. We woke him to make sure he was okay. We offered him medical and homeless outreach services and he refused needing any kind of assistance. **Disposition: NCR.**
- 23:11 4076 18. Street. Well-being Check (910)- BMA sleeping on the bench of Reville café. There was no MPC-25 sign posted. We woke him up to make sure he was alive. We asked if he was in need of any services and he refused. Disposition: NCR.
- 23:18 00 Block Hartford Street. Trespass and Destruction of Property (594)- BMA and BFA sitting on the ground of private property on Hartford street. We witnessed the BMA intentionally step on the homeowner's bush/plant right before we walked up. We shined our lights on them and asked what he was doing and he lived there. They did not live there and we asked them to leave that property and told him not to destroy any more of their property as we saw him step on the plant. They said that the homeowner had already asked them to leave and that they were just gathering their things before leaving. Disposition: HAN.

• 23:21 00 Block Hartford. Blocking the sidewalk (22)-We observed a WMA on his knees gathering something from the ground. He said that he dropped and broke his pipe or his weed holder and he was picking up the pieces. Then we heard more people sitting in the dark just a little up the block. We shined the flashlight on them and they shined one back at us. There were three of them sitting, HMA, WMA, and WFA sitting on the ground. The HMA had a bike that was blocking most of the sidewalk and some other bags that belonged to the first guy we spoke with picking up his broken pieces. We asked them to move the bike and not block the sidewalk. They complied. **Disposition: HAN.** 

- 23:24 00 Block Hartford Street. Well-being Check (910)- WMA sleeping on the sidewalk in the light. We woke him and asked if he needed medical or homeless outreach attention and he said no. Disposition: NCR.
- 2340 Castro Theater Parking Lot. Trespassing

(25MPC)- 1 encampment with 2 WMAs under a tarp and another WMA sleeping in the parking lot with two dogs. We told them that they needed to pack up and couldn't be in the parking lot. The guy with the tarp knew right away and started cleaning up. The guy with the dogs said that he's been sleeping there for two months and no one else has asked him to move and also that the gates don't get locked at night anymore anyway. We explained to him that there was a city ordinance stating that there is to be no loitering in the city run parking lots. Both guys slowly starting to pack up and leave the lot. At the same time Antjuan also drove in and asked them both to leave the lot. Eventually they both left. **Disposition:** 

- 00:15 498 Castro street. Well-being Check (910)-BMA asleep against the 18<sup>th</sup> street side of the 24 hour Walgreens. We woke him and asked if he was in need of assistance either medical or shelter. He said no and we asked him to make sure that his bags were not blocking the walking path and to put them up against the wall also. Disposition: NCR.
- **00:18 Walgreens Parking Lot. Loitering (25MPC)**-WMA and HFA standing outside of their car. We asked if they were planning to leave the parking lot because they were not allowed to loiter according to the no trespassing signage. They explained that they would leave in their car. **Disposition: HAN.**
- 00:20 Unit block of Collingwood @ parking lot exit.
  Dog off leash (41.12)- WMA with a dog off leash. We told him that the dog needed to be on a leash and tethered to something or held by him, the owner. He said that he had a leash on him but we explained that the leash couldn't just be loose and attached to the dog without being tied on the other end to something as well. Disposition: ADV.
- 00:23 4200 18 street. Belligerent individual (415)-BMA and WFA looking through a purse at the corner of Collingwood and 18 Street. We walked up and asked if everything was okay. The girl said yes and that they were just looking for a cigarette but the guy quickly began cussing at us telling us to go away. We said there's no need to

become angry as we were just making sure they were okay and wondering what they were doing. He became more hostile and started yelling and cussing more. We called Antjuan to come and talk to this guy and they began walking away, north on Collingwood toward market while still yelling back at us even though the girl was apologizing. We called Antjuan to cancel the call. **Disposition: HAN.** 

## $\cdot$ 00:27 The Edge. Man throwing/breaking glass

**bottles (594)-** After the last incident had ended we heard glass breaking down toward the 4100 block of 18<sup>th</sup> street. There was a WMA in the street throwing glass bottles up in the air and letting them hit the street pavement and break. We approached him in front of the Edge bar and asked him why he's throwing glass and that he shouldn't be doing that. He just rambled nonsense and walked past us toward 18<sup>th</sup> and Castro. We followed him and called Antjuan again to give him a heads up as the subject walked north on Castro street towards

Market. **Disposition: ADV**
