## CCOP PATROL REPORT: Saturday 05/20/2017 ROVING FOOT PATROL (RFP) 21:30-00:20

## **PATROLLERS:**

CONDITIONS: A perfectly clear and not cold night, about low to mid 60s (Fahrenheit). Jon was working Castro Cares, Antjuan driving the PSP beat, and A.J. watching the door at badlands.

NOTABLE INCIDENTS:

• **21:44 South side of 2500 block of Market Street**. <u>Well-being check and</u> <u>Encampment (910)</u>- WMA with a dog living in a small green tent next to

the abandoned muni underground tracks. We woke him to check on his well-being first and offered medical services but he declined the need. We then told him that he's not technically allowed to be in an "encampment." He told us the cops already left him alone after walking by and we said that we just want to advise him that it isn't allowed and continued our patrol. Disposition: ADV.

- **21:47 Harvey Milk Plaza**. <u>Well-being check (910)</u>- WFA and WMA sitting in Harvey Milk plaza with items strewn around them. We asked them that when they plan on leaving, if they could please pick up anything that belonged to them and not leave a mess. Disposition: ADV.
- 21:51 West side corner of 17<sup>th</sup> street and unit block of Hartford Street. <u>Well-being check (910)</u>- WMA sleeping on the west side of Hartford on the sidewalk. He had some clothes and food and soda cans around him. We woke him up, asked if was okay or in need of medical attention. He said no but he wanted food. He had a veggie tray next to him and stated that he had peanut butter and crackers but he needed jelly. We told him that we did not have any with us and wished him a good night. Disposition: NCR.
- 22:21 Castro Theater Parking Lot. Loitering (MPC 25)- 3 WMAs sleeping and loitering in the parking lot. 2 were together and 1 guy by himself. The two guys who were together knew the drill and said that they were going to leave the lot when they saw us. The other guy claimed that he was with the Castro Theater load out guys who were sitting in their truck and showed us their IDs but they denied him being part of their group. We asked him to please find another spot outside of the parking lot and he complied. Disposition: ADM
- 22:26 Castro Theater Parking Lot. <u>Illegal Parking (587)-</u> Black 4 door Audi A8L parked illegally in the spot next to the disabled persons parking, which is not actually a spot but the handicap ramp. Lic# was CA-Disposition: REC.
- 22:32 19<sup>th</sup> street @ Diamond Street behind baseball field backstop. <u>Well-being check (910)-</u> WMA and WFA sitting with a lot of stuff behind the baseball backstop on the North East corner of 19<sup>th</sup> street and Diamond. Disposition: NCR.
- 22:35 211 Diamond street. Intoxicated person (811)- We walked past a tall heavily built WMA wearing shorts and a black t-shirt. He was walking while looking down at his phone and was a little wobbly. We asked him if he was okay. He said he was looking for his car and we could tell right away that he was intoxicated. We advised him not to drive and to take an Uber or Lyft instead. He then told us his phone was at 8% and he was calling his friend but he wasn't answering. We tried to urge him to call for

a car to go home before his battery died but then he received a text and said that his friend was going to meet him at the Edge. We stayed with him a little while longer until he decided to walk back down to the Edge where we saw him again later. Disposition: NCR.

- 22:46 100 Diamond street. <u>Well-being check (910)-</u> WMA was sleeping in front of MHR church so we went to check on him. He had a blanket and a backpack and his area was clean. We chatted a little with him and offered him medical attention and/or shelter by the H.O.T. team but he said he was fine where he was and that he wouldn't bother anybody and be gone by the morning time so we left him and continued on. Disposition: NCR.
- 22:51 4222 18th street. Intoxicated Person (811)- For the first time we encountered one of Ken's real-life training scenarios. A couple people approached us with concern for a man who was apparently lying down sleeping with his upper body on the sidewalk and his legs in the street directly in front of a parked car. If someone had approached the car from the rear driver's side and driven off, they most definitely could have run over this man. He was a WMA wearing a blue tank top and light colored shorts with sunglasses on. There was already another gentleman making a call to SFPD as we walked up. We assessed the situation and determined that there was no apparent blood or trauma. We announced ourselves and shined our flashlight through his sunglasses at his eyes to wake him up. We had one patroller stand at the driver's side of the car to make sure no one got in and drove off. The man woke up after a minute and stood up to talk to us. He was a little shaky getting up but he didn't seem overly intoxicated, said he was just sleepy and on his way home. We asked him if he was going to get home okay and he said that he didn't live too far away. He left, headed West on 18<sup>th</sup> toward Diamond Street. Luckily he did not get his legs run over by the parked car. Disposition: HAN.
- 22:57 Muni bus stop at 4106 18<sup>th</sup> street. Suspicious Behavior (917)-There was a SUV parked in the bus stop picking people up. It did not seem to have any marks of Uber or Lyft. In front of the car appeared a WMA asking the driver to pop the hood. This is the man who refers to himself sometimes as secret agent man whose name I will not disclose. We got his attention and got him back onto the sidewalk so that the car could leave. They began talking out of the window and encouraging him more and I told them to not talk to him and to leave before they got a ticket from the Muni bus that was coming so they left. Secret agent man began to engage in conversation with us and we answered with short answers so as to not become too involved with him. He began doing some strange things, definitely on some kind of

drug, and we continued walking, making sure he wasn't following too closely behind. Disposition: HAN.

- 23:01 496 Castro Street. Well-being check (910)- WMA and WFA sleeping against the east side of Walgreens under the window displays. We woke them up to ask how they were doing. We offered to call for medical attention or shelter if they needed it but they declined. As we began getting negative remarks from the public walking by to leave them alone, we just asked the two sleeping if they would be sure to pull in closer to the wall so that their feet were not in the walkway where someone could trip. Disposition: NCR.
- 23:16 Harvey Milk Plaza. <u>Smoking in a park (SFHC 191)-</u> There was a WFA with red hair smoking right in front of Soul Cycle in Harvey Milk Plaza. We advised her that she was only allowed to smoke outside of the bricked walkway. She apologized and quickly complied, moving outside of the plaza/park. Disposition: ADV.
- 23:21 2450 Market street carport. <u>Trespass (610)-</u> WFA camped next to a car in the carport of 2450 Market, along 17<sup>th</sup> street. She has garbage there and was just sitting. She declined Medical and HOT assistance. We then told her that she was not supposed to be loitering in this carport and the residents have asked that no one be allowed to sleep and trespass in there. We asked her to pick up her stuff and move and told her we'd be back around to check that she has left. Disposition: ADV.
- **23:50 Jane Warner Plaza**. <u>Sleeping in a park (SFPC 3.13)-</u> We saw PSP Officer Fitzinger doing a well-being check and attempting to wake a sleeping person under a blanket in Jane Warner Plaza. We went to provide some support to him. After a couple unsuccessful attempts at trying to wake the person, we gave it a try with a loud "Hi, Castro Patrol," and the person woke up right away. Officer Fitzinger then proceeded in asking the person to please find another place to sleep and they complied with no problem. Disposition: ABA.
