NOTABLE INCIDENTS:

- 22:03 - 4091 Castro Street – Suspicious Person / Dog Off Leash (SFHC-F1; 22; 917; 919) : Eastbound corner of 18th and Castro, Noted a alert and oriented

WF and WM J subjects with German Shepard mix dog. Observed dog laying and subjects obstructing walkway via sidewalk. Subjects noted above advised to ensure dog is on leash and looked after. Verified Leash. Cooperative encounter. DISPOSITION: ADV

- **22:16 – Castro Theatre Parking Lot - Loitering (MPC25):** 4 x HMA in a Black Honda Accord- CA [REDACTED]. Informed them of the no loitering ordinance. They complied. DISPOSITION: ADV
- **22:18 – Castro Theatre Parking Lot - Loitering (MPC25):** WMA with sleeping items and a blanket in-between fencing and vehicles. Informed individual of the no loitering ordinance. Individual complied and left the lot. DISPOSITION: ADV
- **22:19 – Castro Theatre Parking Lot - Loitering (MPC25):** WMA individual with two dogs and sleeping items in the North West corner of the lot. Informed suspect WM of the Trespassing Sign and Loitering in parking lots. Individual was coherent and alert. Refused Medical and HOT assistance. Advised of the no loitering ordinance and was provided 10 minutes to organize his belongings and leave. DISPOSITION: ADV
- **22:21 – Jane Warner Plaza - Smoking (SFHC 191):** Pedestrians reminded of the sign restricting smoking in Jane Warner Plaza. DISPOSITION: ADV
- **22:48 – 7 Eleven of 18th and Noe Street – Suspicious Person (917):** WMA pedestrian with animated and amplified voice who seemed to be talking to himself. Approached to determine if he needed assistance but became agitated when approached. DISPOSITION: NCR
- **22:52 – 4000 Block 18th Street - Parking Violation (587):** Black Ford Truck F150 2000 Lic # CA [REDACTED] was parked blocking the crosswalk at the intersection of 18th and Hartford Street. Vehicle engine was running, but no-one was within the vehicle. HMA approached as we began to record details of the vehicle and apologized. DISPOSITION: ADM
- **23:04 4100 Block 18th Street –Parking Violating (587):** HMA in a Black Ford

Truck F150 2000 Lic # CA [REDACTED] blocking the entrance to the Walgreens parking lot. Advised and complied. DISPOSITION: ADV

- **23:07 – Walgreens Parking Lot - Possible Hazardous Materials (535):** Found an apparently discarded small suitcase in the North East corner of the parking lot which was open and had a number of capped syringes scattered around it. Also found a City and County of San Francisco personal sharps container and a plastic bag with cotton balls and swabs etc. As no-one was with the suitcase of syringes, we obtained a sharps container from Walgreens and deposited the syringes into it, then returned the container to Walgreens for safe disposal. DISPOSITION: HAN
- **23:18 – Walgreen at corner of 18th and Castro Street.; Dispute (418):** WMA grabbed BFA's arm to and both began to engage in a heated dispute. BFA was with a group of WFA and BFA's who all engaged in the dispute. We were able to immediately separate the parties. WMA indicated the group of females had insulted him. Females advised the WMA was harassing them. No-one was injured or wanted to press charges. Both parties were advised to leave the area in different directions and complied. WMA was cautioned that he should call police rather than take matters into his own hands as he had done, which amounted to an assault and possible battery if the female had elected to press charges. He conceded the point and both parties left in different directions. DISPOSITION: ADM
- **23:22 Walgreens Parking Lot, Auto Boost / Strip (852):** Black Honda Accord 2014 CA [REDACTED]. Owner and friend approached patrollers in parking lot regarding broken window. Interviewed vehicle owners about their whereabouts and if they saw anyone leave the car as they approached. Reported no one was present when owners approached car. Assisted with broken glass clean up and advised owner to make a report of the loss to Mission Police Station either in person or on-line. Provided the web site for SFPD. DISPOSITION: HAN
- **23:43 431 Castro Street Castro Nails Store - Broken Window (911):** We

noticed the store window had been shattered but was largely still in place, and the owner of the store and an assistant were trying to secure it as we passed. We spoke to them for a few minutes as they advised they had already reported the incident to Officer Fitzinger of the Patrol Special Police. DISPOSITION: HAN

- **23:49 Castro Theatre Parking Lot - Loitering (MPC25):** WMA with the two dogs who had been given 10 minutes to leave was still in the lot in the same location. We made a second contact and during this discussion the individual advised he had Officer Fitzingers approval to sleep there. We called Officer Fitzinger and confirmed he was working with the VA to secure housing for the individual who was suffering from a debilitating leg injury. We ensured the individual was ok for the evening and left him alone for the evening. DISPOSITION: HAN
- **23:55 Castro Theatre Parking Lot, Broken Window (911):** Black Lincoln 4 door vehicle CA Lic # [REDACTED]. We noted the passenger side window was shattered but had not been fully breached. No-one was with the vehicle, and there were no obvious signs of glass on the ground to indicate the damage occurred in the Castro Theatre lot. DISPOSITION: NCR
