# CCOP PATROL REPORT: FRIDAY 05/27/2017 Roving Foot Patrol (RFP) 21:30-24:00 Team #1

## CONDITIONS:

Strong, windy, and cold breeze with clear visibility throughout the night.

### NOTABLE INCIDENTS:

 21:30 4068 – 18<sup>th</sup> street and Eureka 100 block (152 Urination/Defecation in Public): WMA standing at North bus stop on 18<sup>th</sup> street and Eureka. WMA proceeded to urinate in public. Patrol lead responded to matter- informed individual of above code enforcement flashing a light on him from across the street. He was cooperative, although had already finished anyways, as evidence of his statement, "okay" and he zip pants up and held his hands up. Disposition: ABA.

- 21:58 110 Diamond Street Most Holy Redeemer Well-being check (910)-HMA sleeping on the sidewalk against the side of church on the corner of Diamond and 18<sup>th</sup> street covered in a blue blanket. Verbal arousal to wake HMA. Woke via arousal. Offered HOT assistance, shelter referrals, and medical attention, however, citizen declined. Disposition: ADV.
- 22:12 Castro and 18<sup>th</sup> corner Bicyclist on sidewalk (SFTC 7.2.12)- HMA on bicycle heading north on the west side of Castro towards Market Street. Our team provided a verbal request to, "please walk the bike". Bicyclist complied by walking bicycle. Disposition: ADM.
- 22:15 Castro Theater Parking Lot. Loitering (MPC 25)- WMA sitting up in front of some parking spots. We notified him about the no loitering policy and he just nodded his head in confirmation that he would leave the lot. By the time we were leaving he was still sitting there so we told him we'd come back around and make sure he has gone. Disposition: ADV.
- 22:16 Castro Theater Parking Lot. Loitering (MPC 25)- WMA spotted in parking lot for the fourth time. He owns two dogs who were barking loudly as we approached. The owner of Castro Nail Salon gave their permission for this individual to sleep behind their property while the WMA and dogs find shelter/housing. Disposition: HAN.
- 22:23 445 Castro Street, Check on Well-being Check (910) 1 WMA and 1 unidentified MA asleep at doorway of local business. No trespassing sign identified. Offered shelter or medical attention. Both MAs refused services. Cooperative and comfortable trying to stay warm stating that one of them had or was close to hypothermia yet did not request medical attention. Disposition: HAN.
- 22:28 Jane Warner Plaza Check on Well Being (910) BMA and HMA laying down on west side of the plaza. BMA sleeping and HMA watching something on his phone both under a blanket. We asked them to just sit up and be awake as they are not allowed to lay down and sleep in JWP. They both complied by sitting up and we thanked them. We asked if they needed any medical attention or shelter and they declined. Disposition: ADV.
- 22:29 Jane Warner Plaza Check on Well Being (910) 1 WFA; 1 BMA who we thought could have been female at first but identified as male: BMA lying down under blanket while the WFA was sitting up against the plantar. WFA requested medical attention and asked for a band-aid when offered because she had a cut on the sole of her left foot. CCOP did not have the medic bag so we walked down to Walgreens to retrieve some band-aids and alcohol wipes. Disposition: NCR.

- 22:41 Walgreens Corner of 18<sup>th</sup> and Castro Mentally distributed person (800): WMA with white hoodie and grey jean pants began talking to CCOP team. Team acknowledged person by asking him if he was okay or needed help. WMA raised arms up 180 angle left hand in flexed position with thumb gripping a 10 dollar bill and his right hand gripped a microphone. WMA began speaking in a loud volume, sentence structure was not understandable but he wasn't aggressive and kept trying to talk to us. Perceived as word salad. CCOP retreated to reduce behavior and end the interaction. WMA crossed Castro Street heading east on 18<sup>th</sup>. Disposition: HAN.
- 22:45 –Harvey Milk Plaza No smoking in Plaza and Check on Well Being (910): We did a well-being check on a family of three sitting in Harvey Milk Plaza: WFA, WMA, and WMJ. Child had blonde hair –spiked throughout; CCOP reminded of the sign restricting smoking in Harvey Milk Plaza and they put out their cigarettes. We talked to them a bit and asked if everything was okay or if they were in need of medical services or shelter. They explained that they were looking for a hotel for the night and that they had a hotel room the night before and booked for the next day but no luck for this particular night within their price range. They said that if anything they would stay up all night until they could check into their next hotel at 2am. WMA stated looking for housing via shelters.
- 22:52 Harvey Milk Plaza No smoking in Plaza (SFHC 191) Reminded 4 youth -3 WMA and 1 WFA plaza has a smoking restriction. 3 WMA wore blue hats and the WFA wore a black cross body bag. Group of youth walked southbound on Castro Street toward the 24 outbound bus stop. Disposition: ADM.
- 22:53 –In reference to 22:29 Jane Warner Plaza Check on Well Being (910) follow-up: Provided WFA with Band-Aids. Verbally informed BMA lying down on floor, blanketed and non-responsive to CCOP request to sit up. BMA propped himself up on left forearm and began arguing in a rising voice volume. Appeared to be agitated when asked to sit up and said that we weren't asking anyone else to sit up while pointing at the group that we hadn't gotten to yet. BMA began verbally requesting CCOP identification asking if our badges were real and if it belonged to us. BMA demonstrated poor ability to verbally express self. Tangential and presented defiant behavior. We tried to tell him that we had already spoken to the two people next to them and were on our way to the next group but we couldn't be everywhere at once. We called PSP Jon as the individual continued to be loud and aggressive to let him know the situation. He said that he would handle it and our team decided move on to the next group in order to deescalate agitated behavior. Disposition: ADV.

- 22:55 Jane Warner Plaza Check on Well Being (910) 3 people who appeared to be homeless 1 WMA, 1 WFA, and 1 unidentified FA under a blanket. We offered homeless outreach and medical services, however, they refused. Two of them were already sitting up but the FA under the blanket was lying down sleeping so we asked her to sit up for us. Her two friends tried to get her to sit up also, most likely so that we would move on but she was reluctant to do so. After a few more attempts at asking, she finally sat up and we continued on our patrol. Disposition: HAN.
- 23:04 Aveda Hair Salon on Market Street -No Trespass posted Sign Violation (MPC 25): BMA sitting up sleeping at store front door. Informed suspect of the Trespassing Sign in the window. Recommended for him to find a storefront without sign and advised him to move. He said he would move soon and denied any services, medical or otherwise, that we offered. Disposition: ADV.
- 23:30 3500 block 16<sup>th</sup> Street Check on Well Being (910) WMA sitting on sidewalk eating pizza. Performed a well-being check but the individual refused referrals to shelter and stated he was, "okay". Disposition: NCR.
- 23:48 2300 Market Street– Check on Well Being (910) WMA sitting on steps of vacant business. He had a suitcase in front of him and was just sitting. We asked him if he was okay, and noticed he had some blood on his hand, and offered him a band-aid. He confirmed he was all right and refused HOT assistance and medical attention. We noticed a bottle of vodka next to him. We asked if it was his and he said he just found it and he hadn't been drinking it. We asked him to put it away and to not drink alcohol in public and he complied by putting it in his suitcase. Disposition: NCR.
- 23:56 Muni Station Castro and Market Urination/Defecation in Public (152): WMA standing at west side railing proceeded to urinate in public while we were standing talking to the Muni attendant, Mitchell. Patrol lead responded to matterinformed individual of above code enforcement. He said he was going to church station and the muni attendant refused to let him in after that. He advised he walk to the Church station and sober up first and we also told him to next time use the restroom before leaving the bar. Disposition: ADM.
- 00:08 420 Castro Street Check on Well Being (910) WMA sleeping on the bench of Marcellos Pizzaria. We roused him enough to respond to our questions but then he was right back to sleep. We advised him that the restaurant was going to close soon and that he would have to find another place to sleep. WMA refused H.O.T. van and medical attention. Disposition: HAN.
- 00:11 Castro & Market dog off leash (SFHC 41.12) : WFA with a dog off leash walked by us as we were dealing with the previous incident. They got to the stoplight

at the southwest corner of Castro and Market and crossed the street heading Eastbound. The dog is a mix dog, brown fur and WFA was short, medium build. We tried to follow them to advise her that her dog would need to be put on a leash but the muni F train started rolling forward and cut us off. Subjects and dog speed away and we discontinue our pursuit. Disposition: GOA.

- 00:31 Corner of Noe and Market Street Loud engine noise and light on abandoned car: License Plate #: White Infinity M Series. Car was parked and engine was running and lights were on. It was a keyless car with no one inside. We assumed it could belong to someone delivering something so we waited a little bit for someone to show up but the owner did not return to the car while we were there waiting. Disposition: NCR.
- 00:32 Loud Noise nuisance / Disturbing the peace in car (415): Get Around car playing very loud music while stopped at a stoplight; Driver License Plate # Flashed to gain attention. Informed to lower music volume. Driver complied. Disposition: ABA.
- 00:44 Loud Noise nuisance / Disturbing the peace with instruments (415) Walgreens at Castro and 18<sup>th</sup> street: WFA with blonde hair and small beanie banging a flat drumhead with two drum sticks. WMA jumping up and down while playing a guitar and singning loudly. CCOP informed individuals about the 415 code and that this was a residential area as well – people are sleeping. Individuals were compliant by discontinuing the loud music and moved from location quietly. Disposition: ABA
