CONDITIONS: Clear night, brisk with good visibility, 53 degrees

NOTABLE INCIDENTS:

21:58 – 4054 18th St Cars were dodging a pillow that was directly in front of this address. We removed it from the right lane of traffic.

22:21 - 329 Noe St. - Great Tan – (MPC – 25) WMA sleeping in doorway. This man is a regular at this location. He reluctantly complied to our request to please move along and to please be mindful and observe the No Trespassing signs that business have posted.

22:37 – Jane Warner Plaza – Well Being Check (910) – WFA, BMA – 2 Adult transients appeared to be sleeping under their respective blankets however they stirred upon hearing us approach. They refused services and wished us a good night.

23:05 - Hot Cookie - 407 Castro Street - As we walked Southbound on Castro Street we noticed the line for Hot Cookie was blocking the sidewalk. We kindly asked the patrons to form a single file next to the building as to not block the pedestrian flow of traffic.

22:41 - #24 Muni Stop – Northbound @ 17th & Castro – 4 Door blue sedan UBER –Car was parked in the bus lane. Shined the flashlight in motion to the driver to vacate said space due the #24 bus which was approaching from the South at intersections 18th & Castro. Driver immediately understood this cue and quickly sped off allowing the bus to safely drive up and occupy said bus stop.

22:46 - **Castro Theatre Parking Lot - (MPC 25) Trespass – 4 Door Honda CA:** Occupants of this vehicle advised of City Ordinance, complied without incident.

23:11 – Eureka Valley Recreation Center – The gate to the playground on the Collingwood side was unlocked and open. We walked through the grounds to see if anyone was there. We found the gates on Diamond side of the park to be open as well. We contacted DChf. Brian Hill and requested he contact the Ranger to advise of our findings.

23:23 - **Walgreens Parking Lot** - **(MPC 25)** - **BMA** – Lying face down in a pool of water that had collected there. He was unresponsive. We tapped his foot a few times and still no response. We contacted John to call an ambulance. While waiting for EMS to arrive a **WMA** rode up on a bike. He appeared to be yelling to the unresponsive man on the ground. "wake up, they called an ambulance for ya." "Come on, Man, expletive, wake the expletive up." "t was our impression that the BMA was probably in some for of drug haze. He was a clutching a crack pipe in one hand. It was at this moment he had stood the man up on his feet and was giving him chest compressions. The man was quickly shaken awake and they both rode off together. It sounds like a movie but that is exactly what happened. Seeing as we didn't need EMS now, we yelled down to John who was standing at Badlands to cancel the EMS. EMS arrived on the scene. We advised them that the call they came for was canceled. EMA preceded to walk with us towards the second incident, a visibly inebriated man who was passed out in the front seat of his vehicle.

23:24 - Walgreen Parking Lot (MPC 25) - MMA Intoxicated CA: License Plate passed out behind the wheel of his 370-Z. - We contacted 911 to advise that the driver was behind the wheel and attempting to drive away. We managed to communicate with him that we need his keys so he wont be arrested for a DUI. EMS could not help this individual. EMS was originally for the unresponsive BMA. This caused some confusion when SFPD finally arrived to assess the drunk man. It was finally determined he just needed to sleep and the team walked him over to Becks Motel. 00:25- End of Patrol
